

Being a part of land located in the State of Ohio, County of Muskingum, Township of Perry, and being part of Lots 1 and 2 of Woodside Subdivision (Plat Book 8, Page 79), Township 1 North, Range 6 West, bounded and described as follows:

Beginning at an axle found at the northwest corner of Lot 2 of Woodside Subdivision (Plat Book 8, Page 79);

thence North 16 degrees 06 minutes 00 seconds West 54.82 feet to an iron pin set on the west line of Lot 1 of Woodside Subdivision (Plat Book 8, Page 79);

thence through Lot 1 North 73 degrees 54 minutes 00 seconds East 200.00 feet to an iron pin set on the east line of Lot 1 of Woodside Subdivision (Plat Book 8, Page 79), also being on the west line of Airport Road (SR 797);

thence along the east line of Lots 1 and 2 and the west line of Airport Road (SR 797) South 16 degrees 06 minutes 00 seconds East 151.91 feet to an iron pin set:

thence leaving the east line of Lot 2 and the west line of Airport Road (SR 797) South 73 degrees 54 minutes 00 seconds West 200.00 feet to an iron pin set on the west line of Lot 2;

thence along the west line of Lot 2 North 16 degrees 06 minutes 00 seconds West 97.09 feet to the principal place of beginning, containing 0.70 acres, more or less.
