COMMENCING AT AN EXISTING STONE AT THE CENTER OF THE SAID QUARTER TOWNSHIP 3; THENCE SOUTH 86 DEGREES 37 MINUTES 49 SECONDS EAST 510.19 FEET TO AN EXISTING IRON PIN (AXLE) AT THE SOUTHWEST CORNER OF A 26.34 ACRE TRACT CONVEYED TO IVA L. GRAHAM BY DEED RECORDED IN VOLUME 877, PAGE 3 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE WITH THE WEST LINE OF THE SAID GRAHAM TRACT NORTH 07 DEGREES 37 MINUTES 07 SECONDS EAST 281.90 FEET TO AN IRON PIN SET, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE LEAVING THE SAID WEST LINE AND TRAVERSING THROUGH THE WEBER FAMILY INVESTMENTS TRACT THE NEXT FOUR COURSES AND DISTANCES:
