## **DESCRIPTION FOR A 10.148 ACRE TRACT**

**Commencing** at an iron pin found marking the west corner of a 194.672 acre tract (Parcel Number 51-70-03-13-000) as conveyed to Zanesville Muskingum County Port Authority, Official Record 2794, Page 24, the southeast corner of a 20.445 acre tract (Parcel Number 51-60-03-24-000) as conveyed to R. Terry Dutro and Caroline Sue Dutro, Official Record 3134, Pg 251, and the northern line of a 98.12 acre tract (Parcel Number 51-70-03-14-000) as conveyed to Cynthia Merry, Official Record 2985, Pg199

Thence, North 39° 32' 13" East, 1315.66 along the east line of said 20.445 acre R. Terry Dutro and Caroline Sue Dutro tract and the west line of said 194.672 acre tract, passing a 1" pipe found at 892.73 feet making the northeast corner of 20.445 acre Caroline Sue Dutro tract and south corner of a 10.5 acre tract (Parcel Number 51-60-03-05-000) as conveyed to Raymond and Abigail Dutro, Official Record 2980, Pg 115 and passing a 5/8" iron pin found at 1138.93 feet to an iron pin set to the **Point of Beginning** for a 10.152 acre tract;

Thence, North 39° 32' 13" East, 94.36 feet along the east line of said 10.5 acre tract to a 5/8" iron pin set;

Thence, South 87° 41' 53" East, 467.14 feet along what represents a new line across said 194.672 acre tract to a 5/8" iron pin set;

Thence, **South 2° 15' 43" West, 846.83 feet,** along the west right-of-way line of Prosperity Parkway to a 5/8" iron pin set;

Thence, North 87° 40' 48" West, 524.95 feet, with what represents a new line across said 194.672 acre tract to a 5/8" iron pin set;

Thence, North 2° 18' 40" East, 771.54 feet, with what represents a new line across said 194.672 acre tract, to the **Point of Beginning** and containing 10.148 acres, more or less, according to a survey made by Verdantas in July 2023.

The bearings in the above description are based on the Ohio State Plane Coordinates System, South Zone, NAD83.

All iron pins set are 5/8-inch diameter rebar by 30-inch length with red identification caps marked "VERDANTAS 7830".
