BEING A PART OF THE PARCEL CONVEYED TO MARCIA LOUISE JONES, BONNIE JO MILLER, SHERRY JANE SMITH, TERESA JILL KETTLEWELL, SUSAN JALENE JONES, AND JAMES LYNN JONES IN O.R. VOLUME 2907, PAGE 208 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS. SITUATED IN THE SOUTHWEST QUARTER OF SECTION 21, TOWNSHIP 1, RANGE 6, OF THE UNITED STATES MILITARY LANDS, PERRY TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET AT THE SOUTHWEST CORNER OF SECTION 21;

THENCE TRAVERSING INTO THE ABOVE SAID JONES, MILLER, SMITH, KETTLEWELL, JONES AND JONES PARCEL WITH THE WEST LINE OF THE SAID SECTION 21, NORTH 02 DEGREES 23 MINUTES 00 SECONDS EAST 1178.14 FEET TO A POINT IN THE CENTER OF SMITELY ROAD (TOWNSHIP ROAD 198), PASSING AN IRON PIN SET AT 1156.14 FEET;

THENCE LEAVING THE SAID SECTION LINE AND WITH THE CENTER OF THE SAID ROAD THE FOLLOWING THREE COURSES AND DISTANCES:

1. NORTH 68 DEGREES 27 MINUTES 16 SECONDS EAST 201.30 FEET TO A POINT;
2. NORTH 65 DEGREES 26 MINUTES 14 SECONDS EAST 56.96 FEET TO A POINT;
3. NORTH 58 DEGREES 48 MINUTES 57 SECONDS EAST 64.49 FEET TO A POINT ON THE WEST LINE OF A PARCEL CONVEYED TO LARRY E. AND JILL A. MERRY IN DEED VOLUME 1159, PAGE 538 OF THE MUSKINGUM COUNTY DEED RECORDS, SAID POINT BEING SOUTH 87 DEGREES 37 MINUTES 00 SECONDS EAST 26.26 FEET FROM AN IRON PIN SET;

THENCE LEAVING THE SAID ROAD AND WITH THE WEST LINE OF THE SAID MERRY PARCEL THE FOLLOWING TWO COURSES AND DISTANCES:

1. SOUTH 87 DEGREES 37 MINUTES 00 SECONDS EAST 41.48 FEET TO A POINT, PASSING AN IRON PIN SET AT 23.69 FEET;
2. SOUTH 02 DEGREES 23 MINUTES 00 SECONDS WEST, PASSING AN IRON PIN SET AT 62.77 FEET, A TOTAL DISTANCE OF 1320.00 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF SECTION 21, SAID IRON PIN SET BEING NORTH 87 DEGREES 50 MINUTES 07 SECONDS WEST 1020.94 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH LINE OF THE SAID SECTION (NORTH LINE OF A PARCEL CONVEYED TO ERVIN A. AND ADA E. MILLER IN O.R. VOLUME 2430, PAGE 577, NORTH 87 DEGREES 50 MINUTES 07 SECONDS WEST, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 258.66 FEET, A TOTAL DISTANCE OF 330.00 FEET TO PLACE OF BEGINNING.
