Thence along the east line of Section 21, also being the township line, (by deed), North 02 degrees 33 minutes 19 seconds East, 1245.85 feet to a point in Zane Grey Road, (Co. Rd. 199), on the northeast corner of lands presently owned by Gregg C. and Elizabeth A. Taylor, (OR 1147-3), passing an iron pin found at 1162.28 feet;

Thence along the north line of said Taylor lands, South 72 degrees 25 minutes 12 seconds West, 22.58 feet to a point on the right of way of said road, and the principal place of beginning; Thence continuing along the north lines of said Taylor lands, the following two courses:

- 1.) South 72 degrees 25 minutes 12 seconds West, 442.02 feet to an iron pin set, passing an iron pin set at 5.27 feet;
- 2.) South 87 degrees 16 minutes 05 seconds West, 911.40 feet to an axle found on the east line of lands presently owned by Larry Merry, (OR 2509-855);

Thence along the east line of said Merry lands, North 02 degrees 23 minutes 08 seconds East, 461.04 feet to an iron pin set on the southwest corner of lands presently owned by Dan Rose, (OR 1771-762);

Thence along the south line of said Rose lands, North 85 degrees 05 minutes 58 seconds East, 811.41 feet to an iron pin found on the southwest corner of lands presently owned by Ethel L. and Jerry L. Lewis Sr.,(OR 1159-129);

Thence along the south line of said Lewis lands, North 85 degrees 15 minutes 12 seconds East, 60.04 feet to an iron pin found on the west line of lands presently owned by Claudia D. Flynn, and to Transfer on Death to Matthew Flynn, and Melissa Gould, (OR 2297-586);
