BEING A PART OF THE THIRD PARCEL OF TRACT 2 AS CONVEYED TO JEANEEN T. McDANIEL, CAROLYN LARRICK, AND MERRILEE T. ROGERS IN O.R. VOLUME 2840, PAGE 125. SITUATED IN THE NORTHWEST QUARTER OF SECTION 6, TOWNSHIP 13, RANGE 11, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, RICH HILL TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING CONCRETE MONUMENT AT THE NORTHWEST CORNER OF SECTION 6;

THENCE WITH THE NORTH LINE OF THE SAID SECTION 1 AND WITH THE SOUTH LINE OF A PARCEL CONVEYED TO JERRY R. AND MARTHA H. POLLOCK IN DEED VOLUME 575, PAGE 322 AND THE SOUTH LINE OF A PARCEL CONVEYED TO HELEN T. RICHEY IN O.R. VOLUME 2854, PAGE 17, SOUTH 87 DEGREES 47 MINUTES 13 SECONDS EAST 1181.82 FEET TO AN IRON PIN SET AT THE NORTHWEST CORNER OF THE FIRST PARCEL OF TRACT 3 OF THE ABOVE SAID McDANIEL, LARRICK AND ROGERS PARCEL;

THENCE LEAVING THE SAID SECTION LINE AND WITH THE WEST LINE OF THE SAID FIRST PARCEL OF TRACT 3, SOUTH 02 DEGREES 12 MINUTES 22 SECONDS WEST 1329.02 FEET TO AN IRON PIN SET;

THENCE LEAVING THE SAID WEST LINE OF THE FIRST PARCEL OF TRACT 3 AND TRAVERSING THROUGH THE THIRD PARCEL OF TRACT 2, NORTH 87 DEGREES 47 MINUTES 38 SECONDS WEST 103.08 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP) AT THE NORTHEAST CORNER OF A PARCEL CONVEYED TO BRYCE WILLIAM AND RACHEAL LYNN McDANIEL IN O.R. VOLUME 2454, PAGE 72;

THENCE WITH THE NORTH AND WEST LINES OF THE SAID BRYCE AND RACHEAL McDANIEL PARCEL THE FOLLOWING FOUR COURSES AND DISTANCES:

1. NORTH 40 DEGREES 03 MINUTES 22 SECONDS WEST 150.10 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP);
2. NORTH 49 DEGREES 12 MINUTES 57 SECONDS WEST 210.22 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP);
3. SOUTH 80 DEGREES 55 MINUTES 01 SECONDS WEST 166.71 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP);
4. SOUTH 09 DEGREES 05 MINUTES 12 SECONDS EAST 810.92 FEET TO A POINT IN THE CENTER OF CLAY PIKE (COUNTY ROAD 22), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP) AT 796.63 FEET;

THENCE WITH THE CENTER OF THE SAID ROAD AND WITH THE SOUTH LINE OF THE SAID BRYCE AND RACHEAL McDANIEL PARCEL THE FOLLOWING TWO COURSES AND DISTANCES:

1. NORTH 81 DEGREES 13 MINUTES 31 SECONDS EAST 379.46 FEET TO A POINT, SAID POINT BEING SOUTH 09 DEGREES 05 MINUTES 12 SECONDS EAST 18.22 FEET FROM AN EXISTING IRON PIN (5/8 INCH REBAR WITH "GARDNER" CAP);
2. NORTH 81 DEGREES 37 MINUTES 47 SECONDS EAST 0.55 FEET TO A POINT AT THE NORTHWEST CORNER OF THE SECOND PARCEL OF TRACT 2 OF THE ABOVE SAID McDANIEL, LARRICK, AND ROGERS PARCEL;
