

DESCRIPTION OF SURVEY FOR MIKE BROWN

JOB#1300-1

Situated in the State of Ohio, County of Muskingum, Township of Rich Hill:

Being part of the Southwest Quarter, of Section #6, Township #13, Range #11, of the Congress Lands East of the Scioto River, **being part of the M & M Brown** properly recorded in Deed Book Volume 1064, Page 331 of said county's deed records, further known as Muskingum County **Auditor's Parcel Number 53-01-06-10-000**, and more particularly described as follows;

Commencing at an iron pin (found) at the common corner for the Southwest and Southeast Quarters of said Section #6, also for the Northeast and Northwest Quarters of Section #7 of said Township and Range; **THENCE North 02 degrees 30 minutes 25 seconds East 262.54 feet** along the common line for the Southwest and Southeast Quarters of Section #6 to an iron pin (set) at the place of beginning for the property herein intended to be described, passing an iron pin (found) at 53.77 feet and the center line of Tom Road (County Road #22) at 74.01 feet;


- #1- **THENCE North 87 degrees 29 minutes 25 seconds West 531.03 feet** into said Southwest Quarter and through said Brown property to an unmarked point, passing an iron pin (set) at 511.03 feet;
- #2- **THENCE North 22 degrees 04 minutes 55 seconds West 393.15 feet** continuing through said Brown property to an unmarked point;
- #3- **THENCE South 87 degrees 13 minutes 40 seconds East 694.62 feet** continuing through said Brown property to an unmarked point on the common line for said Southwest and Southeast Quarters of Section #6, also being in the roadbed of said road, passing an iron pin (set) at 80.46 feet and 668.76 feet;
- #4- **THENCE South 02 degrees 30 minutes 25 seconds West 354.31 feet** along said Quarter Section line to the place of beginning, leaving said road right of way at approximately 233 feet **containing 5.00 acres.**

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).
