

DEED DESCRIPTION

Situated in the Township of Rich Hill, County of Muskingum, State of Ohio and being 0.0075 acres more or less in the Northwest Quarter of Section # 3, Township # 13 North, Range # 11 West of the Congress Lands East of the Scioto River Survey and being more particularly described as follows:

Commencing at an P. K. Nail set at the Northwest corner of Lot # 1 of Rix Mills as found in Plat Book # 1 Page 183 of the Plat records of Muskingum County, Ohio Thence with the north line of said Lot # 1 S 83° 39' 42" E a distance of 126.00 feet to a point the BEGINNING, Thence with the lands of now or formerly Clarence Pyle as Found in Volume 603 Page 168 of the deed records of Muskingum County, Ohio N 07° 35' 43" E a distance of 44.00 Feet to a point, Thence with a new division line through the lands of now or Formerly Ohio Power Company as Found in Volume 548 Page 48 of the deed records of Muskingum County, Ohio the following three (3) calls:

1. S 83° 39' 42" E a distance of 7.45 feet to an iron pin set.
2. S 07° 35' 43" W a distance of 44.00 feet to an iron pin set.
3. N 83° 39' 42" W a distance of 7.45 Feet to the beginning and containing 0.0075 acres more or less and being a part of the property conveyed to Ohio Power Company in Volume 548 Page 48 of the deed records of Muskingum County, Ohio.


