K. Nail set at the Southeast corner of the North ~~East~~ ^{EAST} Quarter of Section # 4, Thence with the south line of the North ~~East~~ ^{EAST} Quarter of Section # 4 N 83° 39' 42" W a distance of 169.00 feet to the beginning and containing 0.384 acres more or less and being all the property conveyed of William Pyle in Volume 722 Page 64 of the deed records of Muskingum County, Ohio.

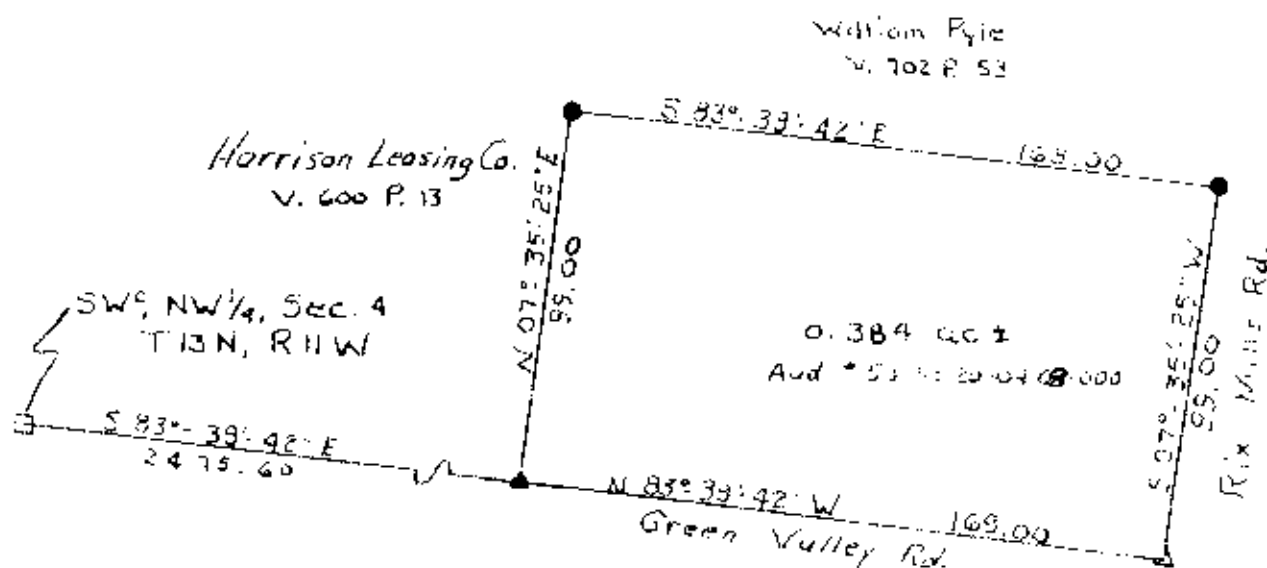
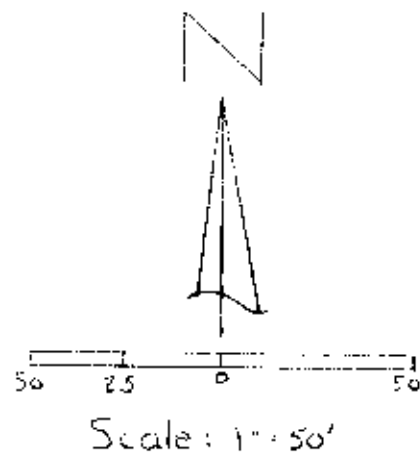
