

DEED DESCRIPTION
FOR
WILLIAM PYLE

Situated in the Township of Rich Hill, County of Muskingum, State of Ohio and being 6.000 acres more or less in the North^{EAST} Quarter of Section # 4, Township # 13 North, Range # 11 West of the Congress Lands East of the Scioto River Survey and being more particularly described as follows:

Commencing at an stone found at the Southwest corner of the North^{EAST} Quarter of Section # 4, Thence with the south line of the North^{EAST} Quarter of Section # 4 S 83° 39' 42" E a distance of 2266.89 feet to a point the BEGINNING, Thence with a new division line through the lands of now or formerly Harrison Leasing Company as found in Volume 600 Page 13 of the deed records of Muskingum County, Ohio the following two (2) calls:

1. N 07° 35' 25" E a distance of 865.99 feet to an iron pin set (having passed through an iron pin set at 30.00 feet),
2. S 83° 39' 42" E a distance of 377.71 feet to an iron pin set on the east line of the North^{EAST} Quarter of Section # 4, Thence with the east line of the North-west Quarter of Section # 4 S 07° 35' 25" W a distance of 477.71⁴¹ feet to an iron pin set, Thence with the lands of now or formerly William Pyle as found in Volume 438 Page 447 of the deed records of Muskingum County, Ohio N 83° 39' 42" W a distance of 169.00 feet to an iron pin set, Thence with the lands of now or formerly said William Pyle as found in Volume 438 Page 447 and volume 602 Page 116 and Volume 702 Page 53 and Volume 722 page 64 S 07° 35' 25" W a distance of 388.58 feet to a Railroad spike set on the south line of the North^{EAST} Quarter of Section # 4 and in C. R. # 83, Thence with the south line of the North^{EAST} Quarter of Section # 4 N 83° 39' 42" W a distance of 208.71 feet to the beginning and containing 6.000 acres more or less and being a part of the property conveyed to Harrison Leasing Company as found in Volume 600 Page 13 of the deed records of Muskingum County, Ohio.

Being a part of Aut. Parcel # 53-53-20-04-09-000.

Subject to all easements or leases of public record.

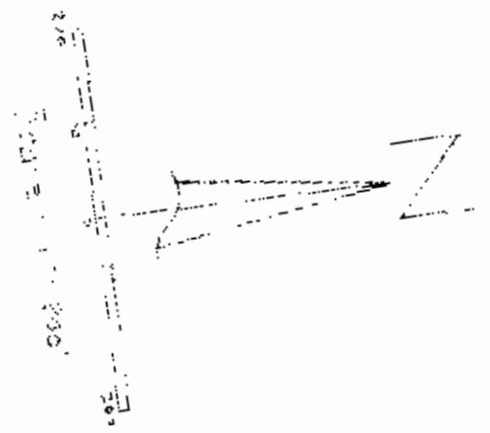
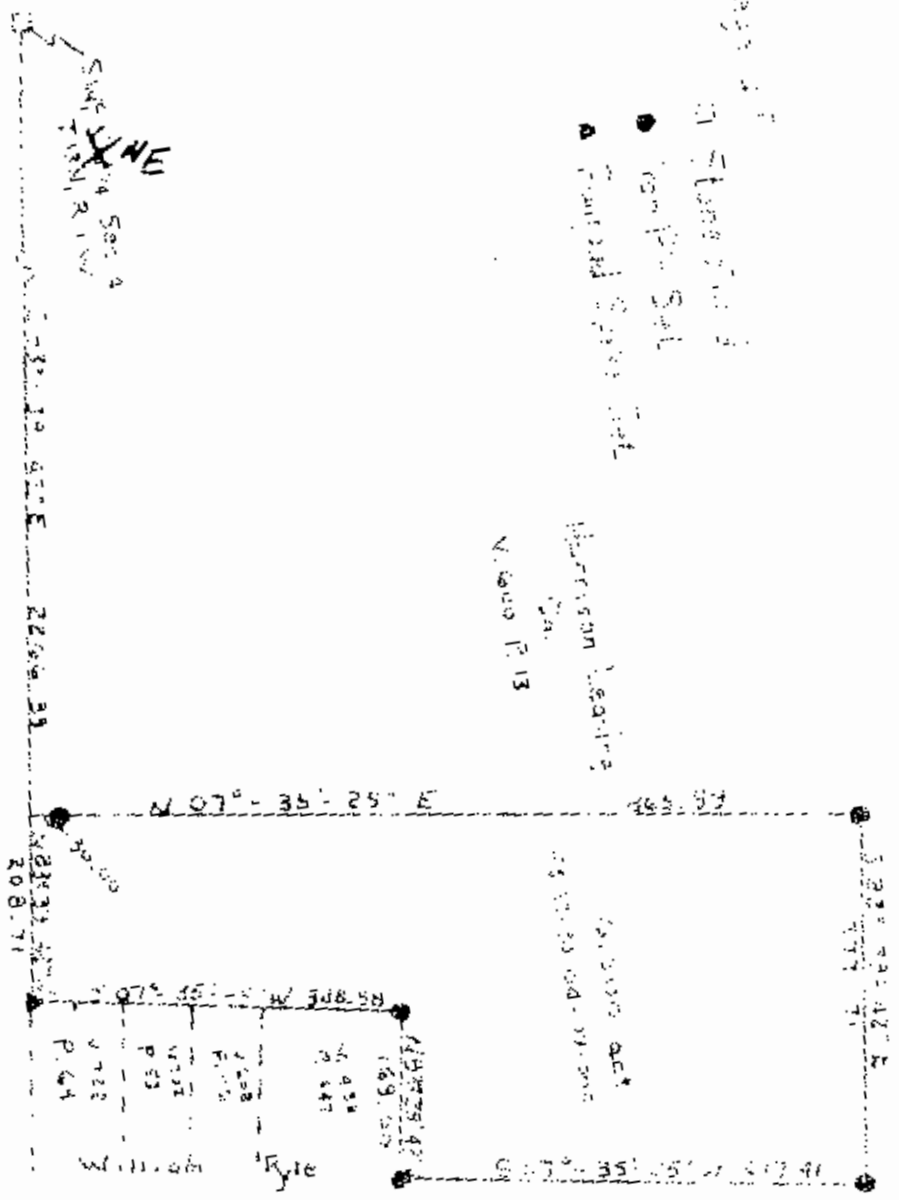
