Situated in the Township of Rich Hill, County of Muskingum, State of Ohio and being 0.945 acres in the southwest quarter of section 4 of Township 13 Range 11 of the Congress Lands East of the Scioto River and being more particularly described as follows,

Commencing at an unmarked stone found at the northwest corner of the southwest quarter of said section 4 thence with the west line of said southwest quarter S 02° 03' 19" W a distance of 2626.00 feet to a point thence leaving said quarter line N 62° 11' 31" E a distance of 1232.60 feet to a point in the center of County road 83 the BEGINNING thence leaving said road and with the lands of Thomas A. and Mary A. Hinze as recorded in official records volume 1862 page 841

S 53° 33' 38" E a distance of 300.00 feet to a 5/8 inch capped rebar found having passed through a 5/8 inch capped rebar found at 30.00 feet thence with a line through the lands of Ruth J. Menzie as recorded in official records volume 2005 page 258 the next three calls,


- 1) S 37° 49' 42" W a distance of 83.83 feet to an iron pin set.
- 2) S 76° 24' 14" W a distance of 77.90 feet to an iron pin set.
- 3) N 53° 52' 32" W a distance of 240.52 feet to a point in the center of County road 83 having passed through an iron pin set at 218.64 feet thence with the center of said County road 83 and continuing through the lands of said Menzie the next two calls,

- 1) N 31° 22' 32" E a distance of 74.77 feet to a point.
- 2) N 35° 46' 24" E a distance of 70.36 feet to the BEGINNING and containing 0.945 acres and being a part of the property conveyed in official records volume 2005 page 258 and being a part of auditors parcel # 53-20-04-14-000





