Thence along the west line of said Herron, and Burkhart lands, South 02 degrees 42 minutes 28 seconds West, 271.17 feet to a point in the centerline of Herron Road, (Co. Rd. 448), passing an iron pin set at 245.49 feet;

Thence along the centerline of said road the following three courses:

- 1.) South 67 degrees 42 minutes 37 seconds West, 188.29 feet to a point;
- 2.) Along a non-tangent curve to the left having a delta angle of 36 degrees 51 minutes 53 seconds, a radius of 336.38 feet and an arc length of 216.43 feet, and a chord which bears South 53 degrees 06 minutes 42 seconds West, 212.72 feet to a point;
- 3.) South 39 degrees 44 minutes 46 seconds West, 19.31 feet to a point on the northeast corner of lands presently owned by Max Brill, (OR 2233-908);

Thence along the lines of said Brill lands the following four courses:

- 1.) North 65 degrees 02 minutes 05 seconds West, 206.51 feet o a point in a creek, passing iron pins set at 25.00 feet, and 194.63 feet;
- 2.) South 48 degrees 04 minutes 01 seconds West, 235.05 feet to a point in a creek;
- 3.) South 15 degrees 35 minutes 28 seconds West, 262.48 feet to an iron pin set on the edge of a creek;
- 4.) Leaving said creek, North 86 degrees 40 minutes 59 seconds East, 109.10 feet to a point in the centerline of Herron Road, (Co. Rd. 448), passing an iron pin set at 78.76 feet;

Thence along the centerline of said road the following four courses:

- 1.) South 45 degrees 24 minutes 07 seconds West, 139.77 feet to a point;
- 2.) South 41 degrees 17 minutes 21 seconds West, 170.35 feet to a point;
- 3.) Along a non-tangent curve to the left having a delta angle of 14 degrees 17 minutes 30 seconds, a radius of 1336.08 feet, and an arc length of 333.27 feet, from which a chord bears South 34 degrees 52 minutes 48 seconds West, 332.41 feet to a point;
- 4.) South 29 degrees 59 minutes 33 seconds West, 92.11 feet to a point on the northeast corner of lands presently owned by James Andrew and Marla J. West, (OR 2033-283);

Thence along the north lines of said West lands, the following five courses:

- 1.) North 74 degrees 28 minutes 37 seconds West, 268.34 feet to an iron pin found, passing an iron pin found at 22.54 feet;
- 2.) South 69 degrees 43 minutes 11 seconds West, 62.70 feet to an iron pin found;

- 3.) North 46 degrees 46 minutes 49 seconds West, 236.84 feet to an iron pin found;
- 4.) North 28 degrees 46 minutes 49 seconds West, 280.50 feet to an iron pin found;
- 5.) North 88 degrees 46 minutes 49 seconds West, 946.94 feet to an iron pin found west line of Section 16, and the east line of lands presently owned by John H. Ross, (OR 2007-40);

Thence along the west line of Section 16, and the east line of said Ross lands, North 02 degrees 33 minutes 15 seconds East, 942.17 feet to the principal place of beginning, containing 55.26 acres, more or less.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5\8 inch rebars, 30 inches long, with plastic identification caps.
