Being a part of the Southeast Quarter of Section 5, Township 2, Range 6, United States Military District, Salem Township, Muskingum County, Ohio and being further described as follows:

Commencing at an existing 5/8 inch rebar marking the Southeast corner of Section 5; thence North 90 degrees 00 minutes 00 seconds West 1286.92 feet (1320 feet by deed) along the South line of said Section to an existing stone, said stone being the place of beginning of the tract herein intended to be described; thence continuing along said South line North 90 degrees 00 minutes 00 seconds West 500.00 feet to an iron pin set; thence leaving said South line North 00 degrees 13 minutes 32 seconds East 1269.89 feet to a point in the center of County Road Number 40, passing an 1ron pin set at 1243.89 feet; thence South 75 degrees 42 minutes 44 seconds East 158.45 feet to a point in the center of said County Road Number 40; thence South 76 degrees 33 minutes 38 seconds East 341.55 feet to a point in the center of said County Road Number 40; thence South 00 degrees 27 minutes 40 seconds East 1150.43 feet to the place of beginning, passing an iron pin set at 25.00 feet.

All iron pins are 5/8 inch rebar with identification cap.


