COMMENCING AT AN IRON PIN MARKING THE SOUTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION 4;

THENCE SOUTH 87 DEGREES 53 MINUTES 12 SECONDS EAST 508.04 FEET ALONG THE SOUTH LINE OF SECTION 4 TO AN IRON PIN SET, SAID IRON PIN SET BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE NORTH 04 DEGREES 45 MINUTES 44 SECONDS EAST 662.84 FEET TO A POINT IN THE CENTER OF COUNTY ROAD 40 (MOLLIES ROCK ROAD), PASSING AN IRON PIN SET AT 632.84 FEET;

THENCE ALONG THE CENTER OF COUNTY ROAD 40 (MOLLIES ROCK ROAD), SOUTH 66 DEGREES 27 MINUTES 38 SECONDS EAST 666.24 FEET TO A POINT;

THENCE CONTINUING ALONG THE CENTER OF SAID ROAD SOUTH 67 DEGREES 01 MINUTES 20 SECONDS EAST 222.63 FEET TO A POINT;

THENCE SOUTH 14 DEGREES 10 MINUTES 57 SECONDS WEST 143.63 FEET ALONG THE WEST LINE OF A TRACT CONVEYED TO H. M. ROSS AS RECORDED IN VOLUME 1146, PAGE 781 OF THE MUSKINGUM COUNTY DEED RECORDS TO AN EXISTING IRON PIN (5/8 INCH REBAR), PASSING AN EXISTING IRON PIN (5/8 INCH REBAR) AT 17.80 FEET;
