

DESCRIPTION OF SURVEY FOR LARRY WISECARVER

Situated in the State of Ohio, County of Muskingum, Township of Salem:

Being part of the Southwest Quarter, of Section #7, Township # 2, Range #6, of the US Military District, being part of the prior deed reference Volume 458, Page 403 of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 56-56-40-07-16-000, and more particularly described as follows;

Commencing at the Northwest corner of said Southwest Quarter; thence (by deed) S 02 57 45 W 1041.48 feet along the West line of said Section #7 to the Northwest corner of said Volume 458, Page 403; thence (by deed) S 87 02 15 E 1445.79 feet along the North line of said Volume 458, Page 403 and North line of the R. Wisecarver property as described in deed reference Volume 729, Page 131 to the center of State Route #93 (Adamsville Road), passing an iron pin (found) at 1414.38 feet; thence S 20 05 00 W 627.76 feet along the center of said road to the Southeast corner of the D. Wisecarver property as described in deed reference Volume 848, Page 139, also being the place of beginning for the property herein intended to be described;

- #1- thence S 20 04 10 W 122.70 feet continuing along the center of said road to the Northeast corner of the W. Wisecarver property as described in deed reference Volume 559, Page 944;
- #2- thence N 75 50 30 W 231.90 feet along the North line of said W. Wisecarver property to a metal fence post (found) at a common corner of said W. Wisecarver property and the Larry Wisecarver property as described in deed reference Volume 929, Page 291, passing an iron pin (found) at 32 feet;
- #3- thence N 19 30 25 E 37.81 feet along a line of said Larry Wisecarver property to a metal fence post (found) at a corner of said Larry Wisecarver property;
- #4- thence N 55 09 40 W 194.84 feet along a line of said Larry Wisecarver property to an iron pin (set) at a corner of said Larry Wisecarver property;
- #5- thence S 87 13 55 E 198.42 feet through said prior deed reference Volume 458, Page 403 to an iron pin (set) at the Southwest corner of said D. Wisecarver property;
- #6- thence S 69 57 15 E 230.00 feet along the South line of said D. Wisecarver property to the place of beginning, passing an iron pin (set) at 200 feet, containing 0.95 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness R.S.6885).

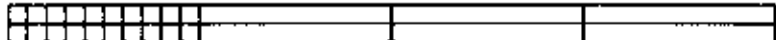
