Commencing at a point marked by an Existing stone at the South West corner of the Northwest Quarter of Section eight; thence North 00 degrees 08 minutes 20 seconds East 1224.77 feet along the West Line of the said Northwest Quarter of Section eight (said West Line also being the line between Salt Creek Township and Wayne Township) to a point said point being the Southwest corner of a 4.00 acre tract thence North 420.09 feet along the said West Line of the said Northwest Quarter to a point in the center of Township Road 389, said point being the place of beginning of this tract passing a point marked by an existing iron pin (½ inch rebar) at 401.09 feet; thence North 00 degrees 03 minutes 22 seconds East 624.14 feet along the said West Line of the said Northwest Quarter to a point marked by an existing iron pin (½ inch pipe); thence South 41 degrees 58 minutes 57 seconds East 445.07 feet to a point marked by an iron pin (all iron pins are 3/4 inch pipe unless otherwise indicated); thence South 23 degrees 40 minutes 55 seconds West 49.88 feet to a point marked by an iron pin; thence North 46 degrees 53 minutes 11 seconds West 164.65 feet to a point marked by an iron pin; thence South 23 degrees 40 minutes 55 seconds West 169.63 feet to a point marked by an iron pin; thence South 12 degrees 00 minutes 54 seconds East 130.87 feet to a point marked by an iron pin; thence South 00 degrees 18 minutes 48 seconds East 138.44 feet to a point in the center of Township Road number 389, passing a point marked by an iron pin at 123.86 feet; thence South 83 degrees 04 minutes 11 seconds West 216.86 feet to the place of beginning.


