Beginning at a stone found at the Southwest Corner of the Southeast Quarter of Section 8; Thence North 02° 05' 40" East along D&C Dingey deed vol. 1141, page 554, and S&K Diamond deed vol. 1154, page 409, 1148.53 feet to a point in center of Chandlersville Road (SR 146 ), passing a iron pin found at 1117.72 feet; Thence along center of Chandlersville Road ( SR 146 ) the next nine courses and distances:  
North 73° 41' 13" East 132.45 feet to a point,  
North 73° 00' 05" East 155.33 feet to a point,

Thence leaving said road South 02° 05' 40" West along C.Revenaugh 1436.50 feet to a iron pin found on the South line of Section 8 , passing a iron pin found at 41.50 feet; Thence along South line of Section 8 North 87° 14' 40" West 1152.80 feet to the Place of Beginning. Containing 34.88 acres more or less.

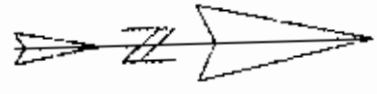
