Situated in the State of Ohio, County of Muskingum, Township of Salt Creek and being part of the of the Southeast Quarter of Section 3, Township 13, Range 12, also being part of the lands now owned by George A. Dailey & Dorothy Mae Dailey (OR 1658-78) of the Muskingum County Recorder more fully described as follows.

Beginning at a point at the southwest corner of said Section 3, thence with the mid-section line, N 02°23'05" E a distance of 1887.70 feet to an iron pin set, passing an iron pin set at 50.00 feet;

thence leaving said mid-section line and going through said Dailey's lands the following three (3) courses:

- 1. N 81°21'32" E a distance of 484.08 feet to an iron pin set;
- 2. N 06°22'50" E a distance of 319.01 feet to an iron pin set;
- 3. N 41°32'21" E a distance of 363.49 feet to a point in the center of Clay Pike (CR-22), passing an iron pin set at 340.71 feet;

thence with the center of said Clay Pike the following four (4) courses:

- 1. S 65°02'39" E a distance of 79.94 feet to a point;
- 2. S 62°16'42" E a distance of 1107.84 feet to a point;
- 3. S $60^{\circ}21'27''$ E a distance of 287.13 feet to a point;

thence with the common line of said Reed/Dailey's lands, S 03°40'49" E a distance of 921.86 feet to a point on the south line of said southeast quarter, referenced by an iron pin found that bears, S 09°59'55" E a distance of 3.13 feet;

thence with the south line of said southeast quarter, N 88°07'37" W a distance of 1191.70 feet to the point of beginning, passing an iron pin found at 300.35 feet, 0.77 feet left of line, containing a total of 86.71 acres more or less, subject to all legal highways and easements of record.
