Situated in the State of Ohio, County of Muskingum, Township of Salt Creek, T 13, R 12, part of the Northeast Quarter of Section 10, bounded and described as follows:

Commencing at a twenty-four (24) inch maple at the Northwest corner of the Northeast Quarter of Section 10; thence along section line South $89^{\circ} 42' 02''$ East 893.53 feet to an iron pin set, the place of beginning; thence along section line South $89^{\circ} 42' 02''$ East 755.12 feet to an iron pin set; thence leaving section line South $1^{\circ} 55' 19''$ East 723.62 feet to the center of Township Road 662 passing an iron pin at 707.62 feet; thence along center of Township Road 662 the following nine (9) courses and distances, North $84^{\circ} 56' 11''$ West 209.53 feet, North $79^{\circ} 27' 16''$ West 75.72 feet, North $51^{\circ} 49' 51''$ West 84.99 feet, North $19^{\circ} 11' 03''$ West 96.31 feet, North $10^{\circ} 36' 32''$ West 41.76 feet, North $23^{\circ} 03' 14''$ West 34.47 feet, North $51^{\circ} 58' 23''$ West 28.22 feet from which an iron pin bears South $88^{\circ} 40'$ East 39.50 feet, North $72^{\circ} 33' 44''$ West 49.52 feet and North $83^{\circ} 34' 13''$ West 379.46 feet to an iron pin set; thence North $9^{\circ} 49' 35''$ East 409.95 feet to the place of beginning, containing 10.19 acres more or less.

Bearings are based on the North line of Northeast Quarter of Section 10 bearing South $89^{\circ} 42' 02''$ East.

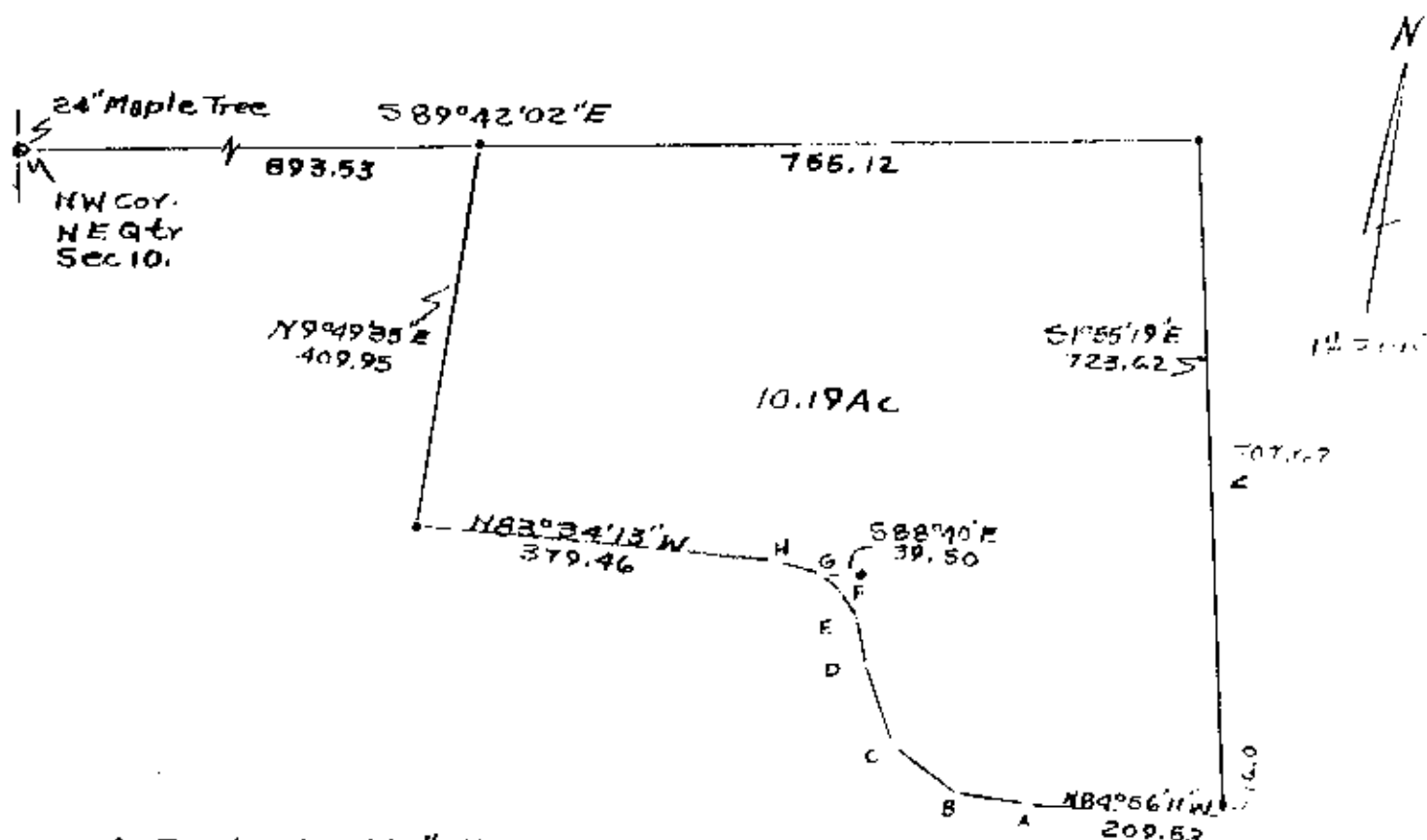
