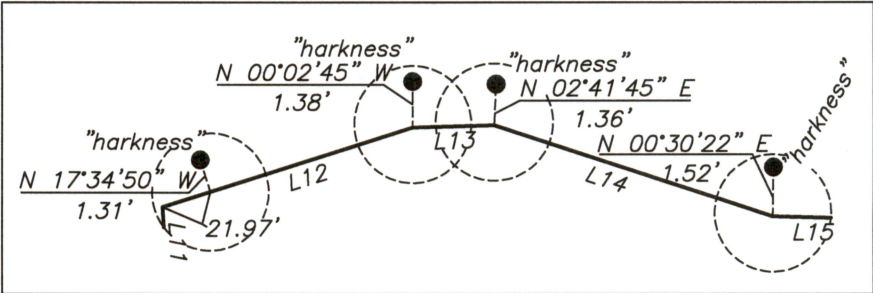

DETAIL AREA



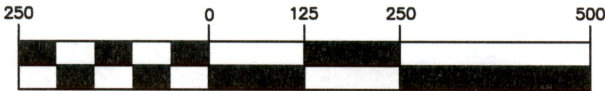
