

Description of Parcel S

Situated in the state of Ohio, County of Muskingum, Township of Salt Creek, being in the southwest quarter of Section 1, Range 12 West, Township 13 North, of "The Congress Land East of The Scioto River", and being bounded and described as follows:

Commencing for Reference at an iron pin set at the southwest corner of Section 1 (Note: Reference bearing on the west line of Section 1 used as North 00°30'51" West.);

thence, with the south line of Section 1, North 89°43'00" East a distance of 547.57 feet to an iron pin set in the centerline of County Road No. 105, being THE TRUE POINT OF BEGINNING for this description;

thence, with the centerline of County Road No. 105, North 01°00'20" West, a distance of 412.36 feet to a point;

thence, leaving the road, South 89°39'43" East a distance of 1,619.83 feet to an iron pin set in the west line of a 30.00 acres tract as conveyed to Joseph Miller by Deed Moline #36, Page 581 of the Muskingum County Recorder's Office, passing through two iron pins set at distances of plus 17.50 feet and plus 17.50 feet, respectively;

thence, with the west line of said Miller property, South 00°36'59" East a distance of 395.00 feet to an iron pin set in the south line of Section 1;

thence, with the south line of Section 1, South 89°43'00" West a distance of 1,619.13 feet to the Point of Beginning, passing through an iron pin set at a distance of plus 1,509.13 feet;

containing 15.04 acres, more or less, being out of Parcel No. 60-30-01-06-006.

Subject to all legal rights-of-way, easements, restrictions, reservations, and zoning regulations of record.

Subject to the right-of-way of County Road No. 105.

Subject to a 30.00 foot wide easement being reserved unto the grantor, his heirs, and/or assigns, forever. Said easement is for the purposes of running utilities to other parcels of land on or near County Road No. 105. Said easement runs in a north-south direction across the west end of the above described property with the west line of said easement being the centerline of County Road No. 105. Containing 0.284 acres, more or less, of easement.



EAST OF THE SCIOTO RIVER".




