SITUATED IN THE NORTHWEST QUARTER OF SECTION 11, TOWNSHIP 13, RANGE 12, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, SALT CREEK TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF SECTION 11, SAID CORNER BEING SOUTH 02 DEGREES 17 MINUTES 31 SECONDS WEST 399.50 FEET FROM AN EXISTING IRON PIN (1/2 INCH REBAR);

THENCE WITH THE NORTH LINE OF THE SAID SECTION (SOUTH LINE OF SECTION 2), NORTH 87 DEGREES 38 MINUTES 13 SECONDS WEST, PASSING AN IRON PIN SET AT 2592.45 FEET, A TOTAL DISTANCE OF 3468.69 FEET TO AN IRON PIN SET, SAID IRON PIN SET BEING **THE PLACE OF BEGINNING** FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED:

THENCE LEAVING THE SAID SECTION LINE AND TRAVERSING INTO THE ABOVE SAID DALEN SCHLABACH PARCEL, SOUTH 15 DEGREES 56 MINUTES 17 SECONDS EAST 596.55 FEET TO A POINT IN THE CENTER OF TUMBLIN ROAD (TOWNSHIP ROAD 390), PASSING AN IRON PIN SET AT 576.65 FEET;

THENCE CONTINUING THROUGH THE SAID SCHLABACH PARCEL WITH THE CENTER OF THE SAID ROAD THE FOLLOWING ELEVEN COURSES AND DISTANCES:
