

### Survey for Board of Wayne Township Trustees

Being a part of land located in the State of Ohio, County of Muskingum, Township of Salt Creek, part of the southwest quarter of Section 20, Township 13 North, Range 12 West.

Being part of the lands conveyed to the Board of Wayne Township Trustees in Deed Record 3080, pages 898-900, bounded and described as follows:

Commencing at the northeast corner of the southwest quarter of Section 20, Township 13 North, Range 12 West;

thence along the north line of said southwest quarter of Section 20 North 87 degrees 45 minutes 00 seconds West 1,006.57 feet to an iron pin found;

thence continuing along the north line of said southwest quarter of Section 20 North 87 degrees 45 minutes 00 seconds West 139.08 feet to an iron pin found;

thence continuing along the north line of said southwest quarter of Section 20 North 87 degrees 45 minutes 00 seconds West 37.26 feet to a point in the centerline of Salt Creek Road (County Road 44) (40' wide right-of-way);

thence along the centerline of Salt Creek Road (County Road 44) (40' wide right-of-way) the following four courses:

1. South 69 degrees 57 minutes 42 seconds West 98.14 feet to a point;
2. South 64 degrees 16 minutes 59 seconds West 97.96 feet to a point;
3. South 59 degrees 20 minutes 10 seconds West 72.24 feet to a point;
4. South 34 degrees 13 minutes 24 seconds West 109.61 feet to a point, the **place of beginning** for this parcel;

thence leaving the centerline of Salt Creek Road (County Road 44) (40' wide right-of-way) and through the Board of Wayne Township Trustees (DR 3080-898) the following eight courses:

1. South 27 degrees 56 minutes 20 seconds East 30.00 feet to an iron pin set;
2. Continuing South 27 degrees 56 minutes 20 seconds East 1,051.34 feet to an iron pin set on the north line of Adam McElhaney (DR 2835-684);
3. Along the north line of Adam McElhaney (DR 2835-684) North 87 degrees 40 minutes 57 seconds West 713.21 feet to a disturbed iron pipe found, being the southeast corner of James A. and Sara N. Stoneburner (DR 2641-603);
4. Leaving the north line of Adam McElhaney (DR 2835-684) and along the east line of James A. and Sara N. Stoneburner (DR 2641-603) North 02 degrees 15 minutes 06 seconds West 348.98 feet to a disturbed iron pin found, being the southeast corner of Sheila A. Pickinpaugh and Jason N. Dempsey (DR 1983-233);
5. Along the east line of Sheila A. Pickinpaugh and Jason N. Dempsey (DR 1983-233) North 02 degrees 15 minutes 06 seconds West 202.71 feet to an iron pipe found;
6. Continuing North 02 degrees 15 minutes 06 seconds West 32.37 feet to a point in the centerline of Salt Creek Road (County Road 44) (40' wide right-of-way), being the northeast corner of Sheila A. Pickinpaugh and Jason N. Dempsey
