Commencing at a concrete monument found at the Northeast corner of the Southeast Quarter of Section 21; thence South  $88^{\circ} 38' 13''$  West 2331.58 feet to a point; thence South  $1^{\circ} 21' 47''$  East 354.17 feet to a point in Westcrest Road, the place of beginning; thence South  $0^{\circ} 27' 38''$  West 739.05 feet to an iron pin set, passing an iron pin set at 30.00 feet; thence North  $79^{\circ} 12' 22''$  West along C. & D. Worstall, Deed Vol. 952, Page 211, 296.00 feet to an iron pin found; thence North  $0^{\circ} 08' 27''$  West along Virginia A. McConaha, Deed Vol. 758, Page 276, 810.25 feet to the center of Westcrest Road, passing an iron pin found at 780.25 feet; thence along the center of Westcrest Road and the South line of Jerry & Judy Squires, Deed Vol. 1024, Page 186, the following five (5) courses and distances, South  $48^{\circ} 59' 21''$  East 147.75 feet to a point, South  $60^{\circ} 49' 29''$  East 74.09 feet to a point, South  $79^{\circ} 31' 49''$  East 58.08 feet to a point, North  $82^{\circ} 12' 32''$  East 38.17 feet to a point and North  $66^{\circ} 50' 36''$  East 30.00 feet to the place of beginning, containing 5.00 acres more or less.

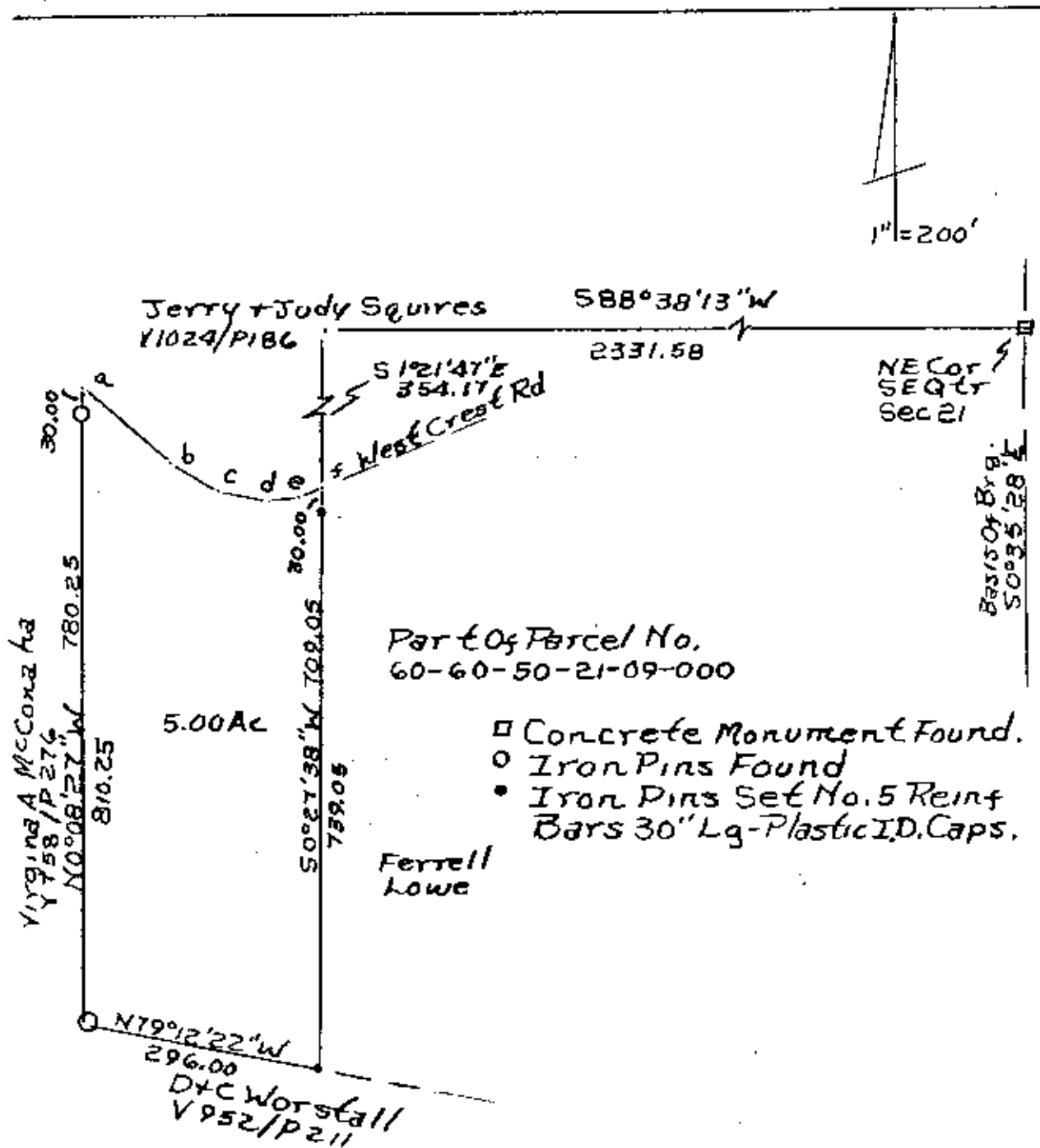
