BEING A PART OF THE PARCEL CONVEYED TO AARON M. ZAMENSKY AND MELISSA L. ZAMENSKY IN O.R. VOLUME 1531, PAGE 439 OF THE MUSKINGUM COUNTY OFFICIAL RECORDS. SITUATED IN MILITARY LOT 4 AND LOT 5 OF QUARTER TOWNSHIP 4, TOWNSHIP 1, RANGE 5, OF THE UNITED STATES MILITARY LANDS, UNION TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN EXISTING IRON PIN (5/8 INCH REBAR WITH BIEDENBACH CAP) AT THE SOUTHEAST CORNER OF THE SAID MILITARY LOT 5;

THENCE WITH THE SOUTH LINE OF THE SAID LOT, NORTH 87 DEGREES 12 MINUTES 13 SECONDS WEST, PASSING AN EXISTING IRON PIN (5/8 INCH REBAR WITH BIEDENBACH CAP) AT 598.62 FEET, A TOTAL DISTANCE OF 618.62 FEET TO A POINT IN THE CENTER OF RIX MILLS ROAD (COUNTY ROAD 55);

THENCE WITH THE CENTER OF SAID ROAD THE NEXT THREE COURSES AND DISTANCES:

1. NORTH 03 DEGREES 37 MINUTES 07 SECONDS EAST 150.00 FEET TO A POINT;
2. NORTH 12 DEGREES 01 MINUTES 58 SECONDS EAST 82.70 FEET TO A POINT;
3. NORTH 13 DEGREES 45 MINUTES 43 SECONDS EAST 138.12 FEET TO A POINT;

THENCE LEAVING THE SAID ROAD AND TRAVERSING INTO THE SAID ZAMENSKY PARCEL, SOUTH 87 DEGREES 12 MINUTES 13 SECONDS EAST, PASSING AN IRON PIN SET AT 30.00 FEET, A TOTAL DISTANCE OF 571.78 FEET TO AN IRON PIN SET;

THENCE CONTINUING THROUGH THE SAID ZAMENSKY PARCEL, THE NEXT THREE COURSES AND DISTANCES:

1. NORTH 01 DEGREES 59 MINUTES 41 SECONDS EAST 135.76 FEET TO AN IRON PIN SET;
2. SOUTH 87 DEGREES 12 MINUTES 13 SECONDS EAST 867.58 FEET TO AN IRON PIN SET;
3. SOUTH 02 DEGREES 47 MINUTES 47 SECONDS WEST 496.80 FEET TO AN IRON PIN SET ON THE SOUTH LINE OF MILITARY LOT 4;

THENCE WITH THE SOUTH LOT LINE, NORTH 87 DEGREES 36 MINUTES 49 SECONDS WEST 860.56 FEET TO THE **PLACE OF BEGINNING**.
