DESCRIPTION OF SURVEY FOR DONNA E BENJAMIN

Situated in the State of Ohio, County of Muskingum, Township of Salt Creek:

Being part of Lots 1 and 2, of the Salt Creek Reserve, recorded in Misc Book 6, Page 14, which is a division of Section 13, of Township 13, Range 12, of the Congress Lands East of the Scioto River, **further being all of** the Donna E Benjamin property recorded in Official Record Volume 2243, Page 334, of said county's deed records, and also being all of Muskingum County **Auditor's Parcel Numbers 60-60-13-02-000 and 60-60-13-03-000**, and more particularly described as follows;

Commencing at an iron pin (found) at the common Northern corner for Lots 2 and 3 of said Salt Creek Reserve, also being the common corner for the Southwest and Southeast Quarters of Section #12 of said Township and Range;

- **#1- THENCE South 87 degrees 33 minutes 10 seconds East 1811.28 feet** along the common line for said Lots 1 and 2 and for Section 12 to an iron pin (found) at a common corner for the Wade H Herron and Janet I Herron property recorded in Deed Book Volume 1127, Page 203, passing an iron pin (set) at the common Northern corner for said Lots 1 and 2 at 1334.52 feet and the centerline of Claysville Road (State Route #313) at 1383.98 feet;
- **#2- THENCE South 22 degrees 37 minutes 30 seconds West 1376.19 feet** crossing said Lot 1 and along said Benjamin and Herron properties to an iron pin (found) on the common line for said Lots 1 and 2;
- **#3-** THENCE South 02 degrees 21 minutes 20 seconds West 314.27 feet and along said Benjamin and Herron properties to an iron pin (found);
- #4- THENCE South 24 degrees 37 minutes 05 seconds West 756.13 feet into said Lot 2 and continuing along said Benjamin and Herron properties to an iron pin (set) at the Northeast corner of the William R Starr and Dorothy R Starr property recorded in Deed Book Volume 527, Page 633;
- **#5- THENCE North 87 degrees 41 minutes 30 seconds West 465.52 feet** along the common line for said Benjamin and W & D Starr property to an iron pin (set) on the East line or the Denzil E Wilson Jr. Property recorded in Deed Book 1140, Page 249;
- **#6- THENCE North 02 degrees 21 minutes 20 seconds East 1268.79 feet** along said Benjamin and Wilson properties also along the Jeffrey P Starr property recorded in Official Record Volume 1940, Page 690 to an unmarked point in the centerline of said Claysville Road, passing an iron pin (set) at 1234.76 feet;
- **#7- THENCE along a curve to the right having, a chord bearing South 67 degrees 39 minutes 25 seconds West 85.49 feet, a radius of 575.00 feet**, and arc length of 85.57 feet, along said road and common line for said Benjamin and J Starr properties to an unmarked point;
- **#8- THENCE South 71 degrees 55 minutes 15 seconds West 368.51 feet** continuing along said road and Benjamin and J Starr properties to an unmarked point;
- **#9- THENCE along a curve to the right having, a chord bearing South 77 degrees 07 minutes 30 seconds West 163.08 feet, a radius of 899.00 feet**, and arc length of 163.30 feet, continuing along said road and properties, also along the Deborah E Shearer and Terry E Stillion property recorded in Deed Book Volume 1144, Page 219 to an unmarked point on the common line fo said Lots 2 and 3;
- **#10- THENCE North 02 degrees 15 minutes 15 seconds East 1246.72 feet** leaving said road and along said Lot Line to the place of beginning, passing an iron pin (set) at 30.00 feet, containing 26.45 acres being Parcel 60-60-13-03-000 and 33.52 acres being Parcel 60-60-13-02-000 for a **Total of 59.97 acres**, of which 2.25 acres are within the right of way for Claysville Road (State Route #313).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
