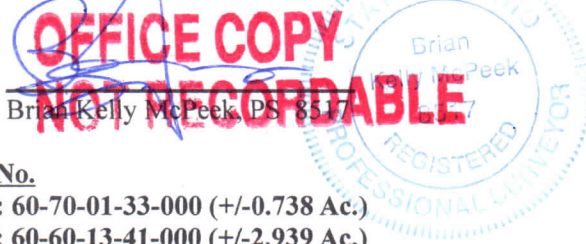
Situated in the State of Ohio, County of Muskingum, Township of Salt Creek, being part of Sections 13 & 14, T13, R12, Congress Lands East of The Scioto River and Being part of the lands now owned by Bradley James Paisley & Haylie Nicole Paisley as recorded in OR 2795-448 of the Muskingum County Recorders Office and being more particularly described as follows.

Beginning for reference at an iron pin found at the southeast corner of Section 14, thence N03°07'56"W, a distance of 981.38 feet to an iron pin set and the principal place of beginning;
thence going through said Paisley's lands, N03°12'50"E, a distance of 331.37 feet to an iron pin set on the south line of the lands now owned by Eric L. & Tammy K. Prouty (OR 2139-117);
thence with the south line of said Prouty's lands, S87°44'38"E, a distance of 613.92 feet to a point in the center of Big Muskie Drive (SR-284), passing an iron pins found at 329.01 feet and 589.20 feet;
thence with the center of said Big Muskie Drive the following two (2) courses:
1. S07°05'36"E, a distance of 83.60 feet to a point;
2. S02°51'11"E, a distance of 80.70 feet to a point;
thence leaving the center of said Big Muskie Drive and going through said Paisley's lands the following three (3) courses:
1. S82°09'16"W, a distance of 339.96 feet to an iron pin set, passing an iron pin set at 25.92 feet;
2. S02°53'01"E, a distance of 85.60 feet to an iron pin set;
3. S87°57'05"W, a distance of 314.08 feet to the point of beginning, containing a total of 3.677 acres more or less, subject to all legal highways and easements of record.

All bearings described herein are based on the Ohio State Plane Grid Coordinates, NAD83, Ohio South per GPS Observation.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.

The above described 3.677 acre parcel is based on a field survey made by McPeek Land Surveying, LLC on August 14th, 2018.
