

**DESCRIPTION OF SURVEY JOB#2730
FOR JAMES E KELLY Jr. & SANDRA J BEEM (AKA SANDRA J KELLY)**

- #8- THENCE South 81 degrees 29 minutes 43 seconds East 16.57 feet** continuing along said road and property to an unmarked corner of the David L Romesberg property recorded in Official Record Volume 2846, Page 175;
- #9- THENCE South 11 degrees 20 minutes 16 seconds West 271.55 feet** leaving said road and along said Kelly and Romesberg properties to an iron pin (set), passing an axle (found) at 29.86 feet;
- #10- THENCE South 78 degrees 48 minutes 17 seconds East 159.20 feet** continuing along said properties to an iron pin (set) on a line of the William O Ault and Clara Sue Ault Trustees property recorded in Official Record Volume 2759, Page 692;
- #11- THENCE South 11 degrees 24 minutes 21 seconds West 172.14 feet** along said Kelly and Ault properties to an iron pin (found rebar 1 1/8" diameter);
- #12- THENCE South 75 degrees 28 minutes 49 seconds East 27.66 feet** along said Kelly/Beem and Ault properties to an iron pin (found capped Finley) at a corner of a second James E Kelly Jr. And Sandra J Beem property recorded in Official Record Volume 1722, Page 811;
- #13- THENCE South 06 degrees 39 minutes 28 seconds West 344.44 feet** along said Kelly/Beem properties to an iron pin (found capped Finley);
- #14- THENCE South 75 degrees 08 minutes 57 seconds East 66.63 feet** continuing along said properties to an iron pin (set) on a line of said Ault property;
- #15- THENCE South 17 degrees 01 minutes 24 seconds West 164.03 feet** along said Kelly/Beem property recorded in Official Record Volume 1503, Page 103 and said Ault property to an iron pin (found);
- #16- THENCE South 20 degrees 51 minutes 35 seconds West 617.92 feet** continuing along said properties to an iron pin (set);
- #17- THENCE North 63 degrees 16 minutes 00 seconds West 282.33 feet** into said Kelly/Beem property to an iron pin (set);
- #18- THENCE North 15 degrees 21 minutes 27 seconds East 114.22 feet** continuing through said property to an iron pin (set);
- #19- THENCE North 39 degrees 35 minutes 20 seconds East 87.70 feet** continuing through said property to an iron pin (set);
- #20- THENCE North 25 degrees 49 minutes 08 seconds West 345.84 feet** continuing through said property to an iron pin (set);
- #21- THENCE North 65 degrees 44 minutes 43 seconds West 158.85 feet** continuing through said property to an iron pin (set);
- #22- THENCE North 02 degrees 56 minutes 45 seconds East 161.14 feet** continuing through said property to the place of beginning, containing 1.49 acres being all of Parcel Number 60-60-14-31-000 and 1.57 acres being all of Parcel Number 60-60-14-33-000, and 12.97 acres being part of Parcel Number 60-60-14-35-003 for a total of 16.03 acres, of which 0.16 acres are within the right of way for Chandlersville Road (State Route 146).

- E1- THENCE South 06 degrees 39 minutes 28 seconds West 66.26 feet** through said 16.03 acre parcel to an unmarked point;
