Situated in the State of Ohio, County of Muskingum, Township of Salt Creek and being part of the Southeast Quarter of Section 33, T13, R12, also being part of the lands now owned by Michael D. Wilson & Galen D. Wilson, Life Estate, Etal as recorded in OR 3149-377 of the Muskingum County Recorder's Office and more particularly described as follows.

Beginning at a concrete monument found at the northeast corner of said southeast quarter, thence with the east line of said Section 33, S 02°54'28" W a distance of 1527.69 feet to to a point at the southeast corner of said Southeast Quarter of Section 33, also being on the north line of the lands now owned by Patricia A. Paul & Ricky J. Warne (OR 2559-652), passing an iron pin set at 1522.69 feet;

thence with the north line of said Paul & Warne's lands, N 87°53'04" W a distance of 543.08 feet to a point in the center of Cutler Lake Road (CR-45), passing a 28" Hickory Tree at 4.48 feet and an iron pin set at 526.03 feet;

thence with the center of said Cutler Lake Road the following four (4) courses:

1. with a curve turning to the left with an arc length of 181.51 feet, with a radius of 1067.21 feet, with a chord bearing of N 13°09'43" W a distance of 181.29 feet to a;
2. N 23°56'04" W a distance of 112.63 feet to a point;
3. N 21°28'06" W a distance of 35.52 feet to a point;
4. N 19°25'06" W a distance of 72.39 feet to a point gin pin set at a southern corner of the lands now owned by Muskingum County Commissioners (OR 2589-394);

thence with the common line of said Wilson, Life Estate, Etal/Muskingum County Commissioners lands the following three (3) courses:

1. N 70°35'24" E a distance of 40.01 feet to an iron pin set;
2. N 19°24'36" W a distance of 65.20 feet to an iron pin set;
3. N 22°09'00" W a distance of 111.56 feet to an iron pin set on the east line of the lands now owned by Allen Parker & Amy Parker (OR 1565-995);

thence with the common lines of said Parker/Wilson, Life Estate, Etal's lands the following three (3) courses:

1. N 41°17'22" E a distance of 265.11 feet to pipe found (1");
2. N 09°58'00" E a distance of 100.00 feet to a pipe found (1");
3. S 63°54'00" W a distance of 344.96 feet to a point in the center of said Cutler Lake Road, passing an iron pin set at 324.86 feet;

thence with the center of said Cutler Lake Road the following seven (7) courses:

1. N 31°11'23" W a distance of 433.54 feet to a point;
2. with a curve turning to the left with an arc length of 109.13 feet, with a radius of 172.29 feet, with a chord bearing of N 50°38'27" W a distance of 107.31 feet to a to a point;
3. N 70°40'16" W a distance of 114.17 feet to a point;
4. with a curve turning to the right with an arc length of 187.59 feet, with a radius of 166.80 feet,
