Situated in the State of Ohio, County of Muskingum, Township of Salt Creek, T-13, R-12, being a resurvey of Carol Wheeler Vol. 2127 Pg. 729, being a part of Section 33, and more particularly described as follows:

Beginning at a State of Ohio concrete marker at the Northeast Corner of Section 33; thence along the East Line of Section 33 South 03 Degrees 07 Minutes 24 Seconds West 2597.12 feet to a State of Ohio concrete marker at the Southeast Corner of the Northeast Quarter of Section 33; thence along the Mid Section Line North 87 Degrees 53 Minutes 13 Seconds West 1322.26 feet to an iron pin set; thence North 03 Degrees 08 Minutes 13 Seconds East 2596.77 feet to an iron pin set, passing iron pins set at 150.97 feet and at 777.29 feet and the centerline of Cutler Lake Road at 121.93 feet and 809.35 feet; thence along the North Line of Section 33 South 87 Degrees 54 Minutes 10 Seconds East 1321.65 feet to the place of beginning, passing iron pins found at 494.41 feet and at 814.41 feet and the centerline of Mock Road at 834.41 feet, containing 78.799 acres, more or less, subject to all legal highways and easements.

Iron pins set are 5/8 inch rebar 30 inches long, with plastic ID caps.

Bearings are based on the North Line of Section 33 as being South 87 Degrees 54 Minutes 10 Seconds East.
