Binkley, Jr., Etal in OR 2168-330 of the Muskingum County Recorders Office more particularly described as follows.

Beginning for reference at a railroad spike found at the southwest corner of said Section 6, thence N 23°24'57" E a distance of 1702.38 feet to a iron pin set on the common line of said Binkley, Jr., Etal's lands and the lands now owned by David Delaney (OR 2016-770), the principal place of beginning;

thence going through said Binkley, Jr., Etal's lands the following five (5) courses:

- N 86°17'33" W a distance of 184.41 feet to an iron pin set;
 N 04°19'15" E a distance of 39.79 feet to an iron pin set;
- 3. N 86°17'33" W a distance of 48.89 feet to an iron pin set;
- 4. S 04°19'15" W a distance of 75.13 feet to an iron pin set;
- 5. N 86°17'33" W a distance of 39.45 feet to an iron pin set on the east line of the lands now owned by Benny L. Binkley Jr. (OR 2870-124);

thence with the east line of said Binkley, Jr.'s lands, N 04°19'15" E a distance of 172.74 feet to a point in the center of Ridge Road (CR-34), passing an iron pin found (5/8" bent and spun) at 146.97 feet;

thence with the center of said Ridge Road, S 86°17'33" E a distance of 270.81 feet to an point on the northwest corner of said Delaney's lands;

thence with the west line of said Delaney's lands, S 03°30'38" W a distance of 137.39 feet to the place of beginning, passing an iron pin found (5/8") at 17.71 feet; containing a total of 0.845 acres more or less, subject to all legal highways and easements of record.
