Being a part of the Southeast Quarter of Sec. 3 and the Northeast Quarter of Sec. 10, Township 16, Range 14, Springfield Township, Muskingum County, also being all of the lands now owned by Bonita Louise Carpenter as recorded in Official Record 1825-734 of the Muskingum County Recorder more fully described as follows.

Beginning for reference at a stone of record at the Northeast Corner of Sec. 10, T16, R14, Springfield Township;

Thence North 86 degrees 46 minutes 36 seconds West, 908.44 feet to a point on the west line of the lands now owned by Clifford & Barbara Miller (DR 518-1013) and the principal place of beginning;

Thence with said west line South 02 degrees 59 minutes 24 seconds West, 124.81 feet to a pk nail set in the center of Ridge Road (CR-34);

Thence with said center of Ridge Road the following 2 courses:

1. South 87 degrees 17 minutes 03 seconds West, 152.50 feet to a point;
2. North 87 degrees 14 minutes 58 seconds West, 38.18 feet to a point, said point being the southeast corner of the lands now owned by Daniel Miller (DR 1095-142);

Thence leaving said center of Ridge Road and going with the east line of said Daniel Miller's lands, North 02 degrees 59 minutes 24 seconds East, 175.09 feet to an iron pin found on the common corner of said Daniel Miller, Bonita Louise Carpenter and Clifford & Barbara Miller's lands, passing an iron pin set at 25.09 feet;

Thence with the common line of said Carpenter and Clifford & Barbara Miller's lands the following 2 courses:

1. South 88 degrees 35 minutes 16 seconds East, 190.00 feet to an iron pin set;
2. South 02 degrees 59 minutes 24 seconds West, 40.19 feet to the point of beginning, containing 0.749 acres more or less, subject to all legal highways and easements of record.

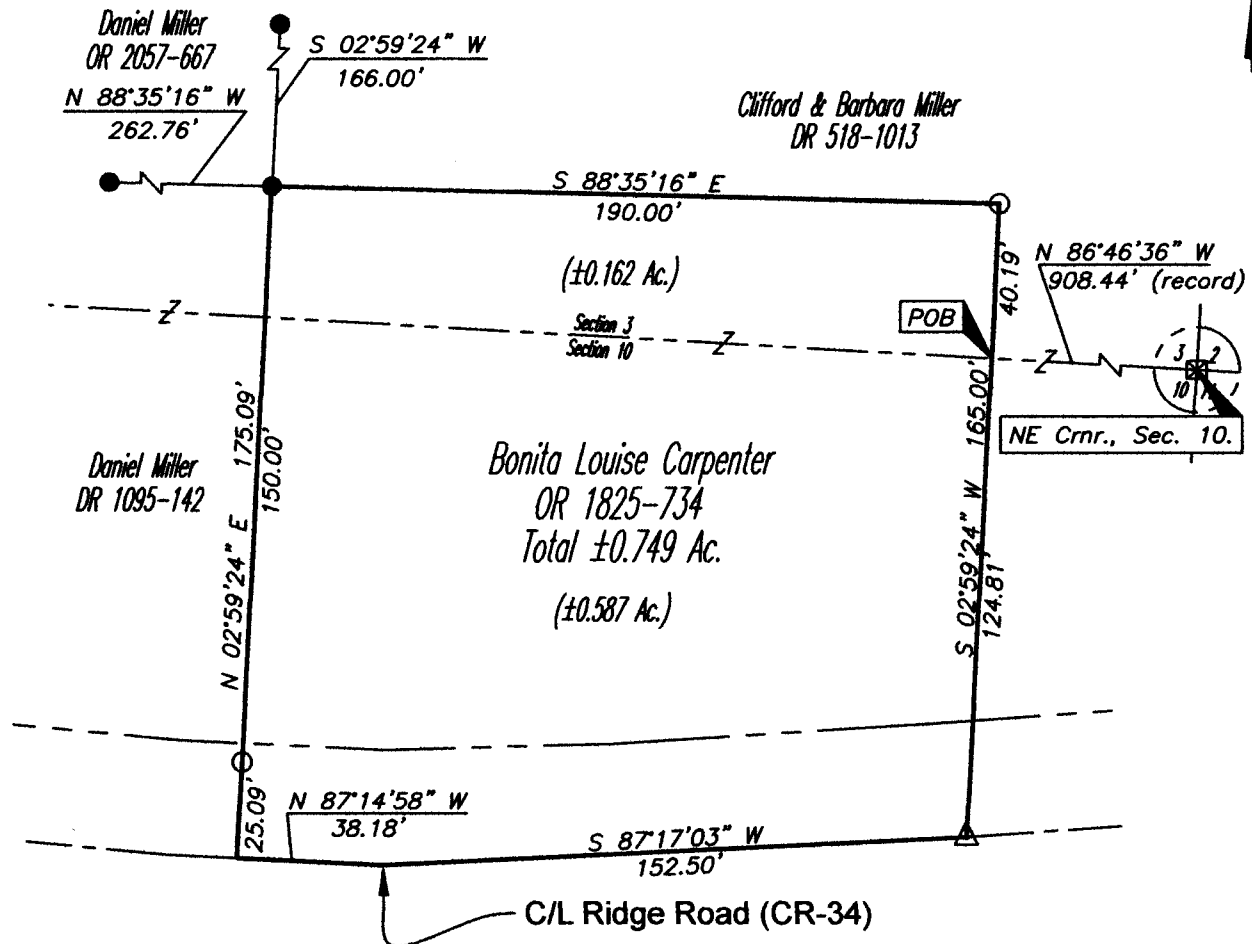
