Beginning for reference at a stone found on the Southwest Corner of Section 7, Township 16, Range 14, Congress Lands East of the Scioto River;

Thence along the south line of Section 7, South 86 degrees 41 minutes 35 seconds East 771.88 feet to point in the centerline of Perine Road, (Co. Rd. 145, R\W 40'), passing an iron pin found at 744.52 feet;

Thence along the centerline of said road the following four courses:

- 1.) Along a non-tangent curve to the right, with a delta angle of 13 degrees 51 minutes 57 seconds, a radius of 855.70 feet, an arc length of 207.08 feet, and a chord which bears North 27 degrees 19 minutes 33 seconds East, 206.58 feet to a point;

- 3.) North 29 degrees 25 minutes 40 seconds East, 419.87 feet to a point;

- 2.) North 19 degrees 09 minutes 00 seconds East, 1626.66 feet to a point in the centerline of Perine Road,(Co. Rd. 145, R\W 40'), passing an iron pin set at 1609.96 feet;

Thence along said centerline the following three courses:

- 1.) South 47 degrees 55 minutes 45 seconds East, 201.88 feet to a point;
- 2.) South 51 degrees 15 minutes 51 seconds East, 108.88 feet to a point;
- 3.) South 55 degrees 19 minutes 51 seconds East, 33.28 feet to a point on the northwest corner of lands presently owned by Ronald Lee Perine, (OR 2582-670);
