**BEGINNING, FOR REFERENCE, AT AN EXISTING CORNER STONE MARKING THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF SECTION #8;**

**THENCE S 0° 56' 35" W 2127.28 FEET, IN THE WEST LINE OF SECTION #8, TO AN EXISTING RAILROAD SPIKE IN THE CENTER OF, ASPHALT SURFACED, COUNTY ROAD #142 [A.K.A. "MEADOW FARM CHURCH ROAD"] AND THE PRINCIPLE PLACE OF BEGINNING OF THE PARCEL HEREIN TO BE DESCRIBED;**

[ THE FOLLOWING 5.01 ACRES PARCEL IS BOUNDED ON THE NORTH, EAST AND SOUTH BY THE AFORESAID "McGEE and WEAVER" PROPERTY AND BOUNDED ON THE WEST BY "COUNTY ROAD #142" AND BY THE PROPERTY OF BERNARD and GERALDINE KUHN OF DEED BOOK 646, PAGE 96, ALL OF THE MUSKINGUM COUNTY RECORDER ]

**THENCE, FROM THE "PRINCIPLE PLACE OF BEGINNING" AND LEAVING THE WEST LINE OF SECTION #8 AND "COUNTY ROAD #142", N 90° 00' 00" E 708.59 FEET TO AN EXISTING IRON PIN, PASSING AN IRON PIN SET AT 25.00 FEET;**

**THENCE S 0° 00' 00" E 306.89 FEET TO AN IRON PIN SET;**

**THENCE S 90° 00' 00" W 713.64 FEET TO A MAG NAIL SET IN THE WEST LINE OF SECTION #8 AND IN THE EXISTING PAVEMENT OF "COUNTY ROAD #142", PASSING AN IRON PIN SET AT 683.64 FEET;**

**THENCE N 0° 56' 35" E 306.93 FEET, IN THE WEST LINE OF SECTION #8, IN "COUNTY ROAD #142" AND IN THE BOUNDARY OF SAID "KUHN" PROPERTY, TO AN "EXISTING RAILROAD SPIKE" AND THE "PRINCIPLE PLACE OF BEGINNING" OF THIS 5.01 ACRES PARCEL.**




