Commencing at an iron pin found at the Northwest Corner of the Southwest Quarter of Section 10; Thence South $19^{\circ}10'56''$ East 351.80 feet to a point in center of County Road 142; Thence leaving County Road 142 South $2^{\circ}03'08''$ West 434.10 feet to an iron pin found the place of beginning; Thence along Lot 1 South $88^{\circ}02'37''$ East 20.00 feet to a point in center of a 40.00 foot wide access road; Thence along the center of access road and Lot 2 the following four courses and distances: South $44^{\circ}55'19''$ West 32.43 feet to a point, South $30^{\circ}19'29''$ West 71.83 feet to a point, South $00^{\circ}13'18''$ West 119.75 feet to a point, and on an 80.00 foot radius curve to the left the chord of which bears South $24^{\circ}42'33''$ East 65.37 feet to a point; Thence leaving access road South $37^{\circ}01'20''$ West along Lot 6, 154.90 feet to an iron pin set passing an iron pin set at 20.00 feet; Thence along R&B Stemm Vol. 904, Page 085, South $80^{\circ}59'45''$ West 150.16 feet to an iron pin set; Thence North $00^{\circ}35'05''$ East 171.35 feet to an iron pin set; Thence North $89^{\circ}24'55''$ West 246.50 feet to an iron pin set; Thence North $00^{\circ}35'05''$ East along D&D Stemm Vol. 585, Page 143, 386.24 feet to an iron pin found; Thence South $88^{\circ}02'36''$ East along L. Joseph Vol. 1129, Page 489, 300.79 feet to an iron pin found; Thence along J&R Frank the next two courses and distances South $1^{\circ}52'43''$ West 131.15 feet to an iron pin found, and South $88^{\circ}02'37''$ East 198.50 feet to the place of beginning containing 4.29 acres more or less: 3.80 acres in Section 9 and 0.49 acres in Section 10.

Also the right to use a 40 foot wide access road to access to Coopermill Road (County Road 142)

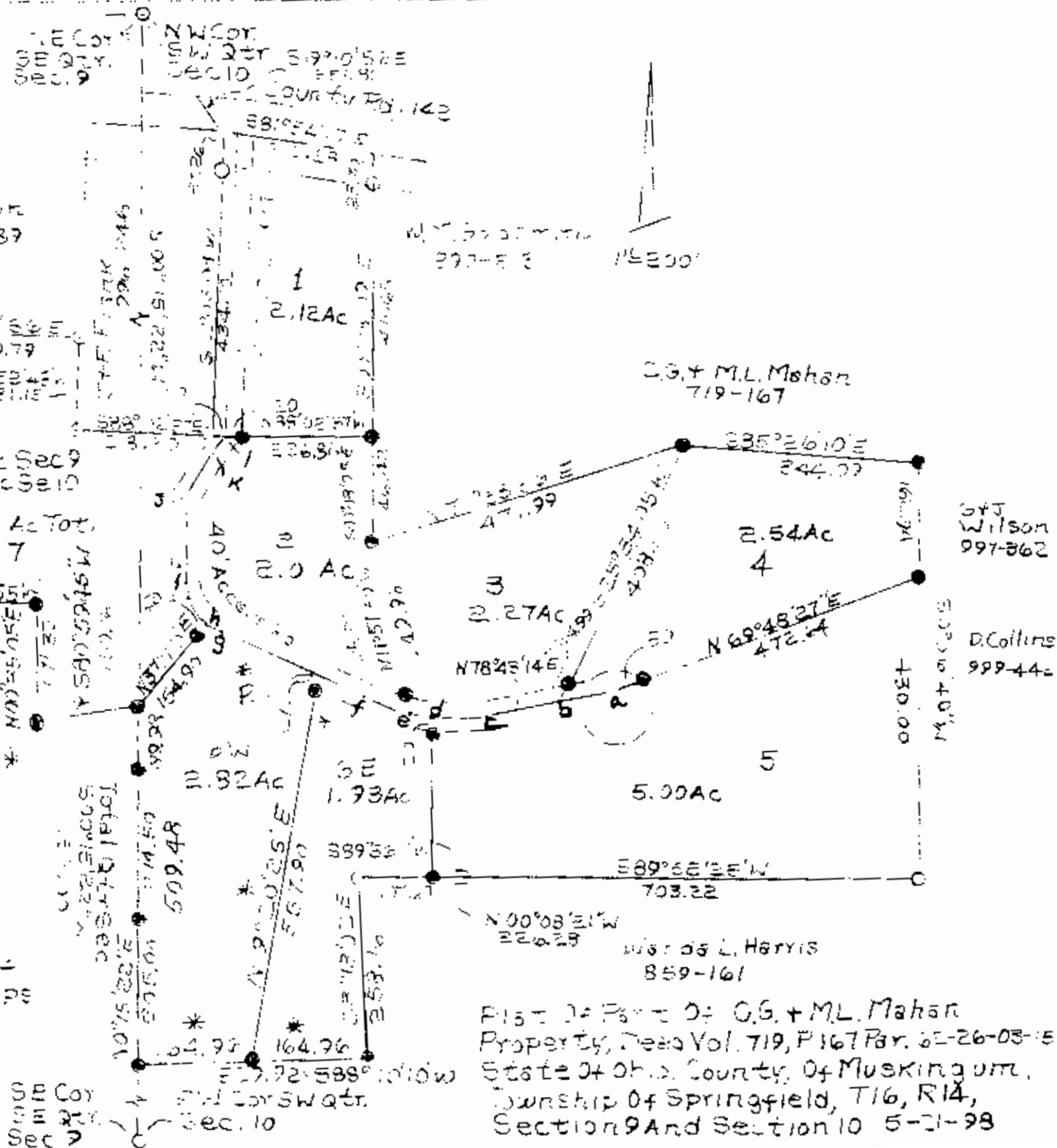
