Being a part of the Southeast Quarter of Section 9, Township 16, Range 14 bounded and described as follows:

Commencing at an iron pin found at the Northwest Corner of the Southeast Quarter of Section 9; thence along the west line of said quarter south 523.21 feet to an iron pin found at the southwest corner of property owned by Tim Shaney by deed recorded in Deed Book 1110, Page 515 and the true place of beginning of the premises herein intended to be described; thence along the south line of said Tim Shaney parcel south 76 degrees 43 minutes 26 seconds east 174.97 feet to a point; thence south 14 degrees 00 minutes 27 seconds east 1039.34 feet to a railroad spike driven in the south edge of the blacktop pavement of Old Coopermill Road; thence south 79 degrees 30 minutes west 254.67 feet to a point; thence north 6 degrees 26 minutes 10 seconds west 170.18 feet to an iron pin; thence north 34 degrees 15 minutes 45 seconds west 196.28 feet to an iron pin; thence south 79 degrees 51 minutes 51 seconds west 42.50 feet to an iron pin on the west line of said southeast quarter of Section 9; thence along the west line of said quarter north 771.18 feet to the true place of beginning, containing six and twenty-six hundredths (6.26) acres more or less.

Subject to the easements of Old Coopermill Road and Pinkerton Road.

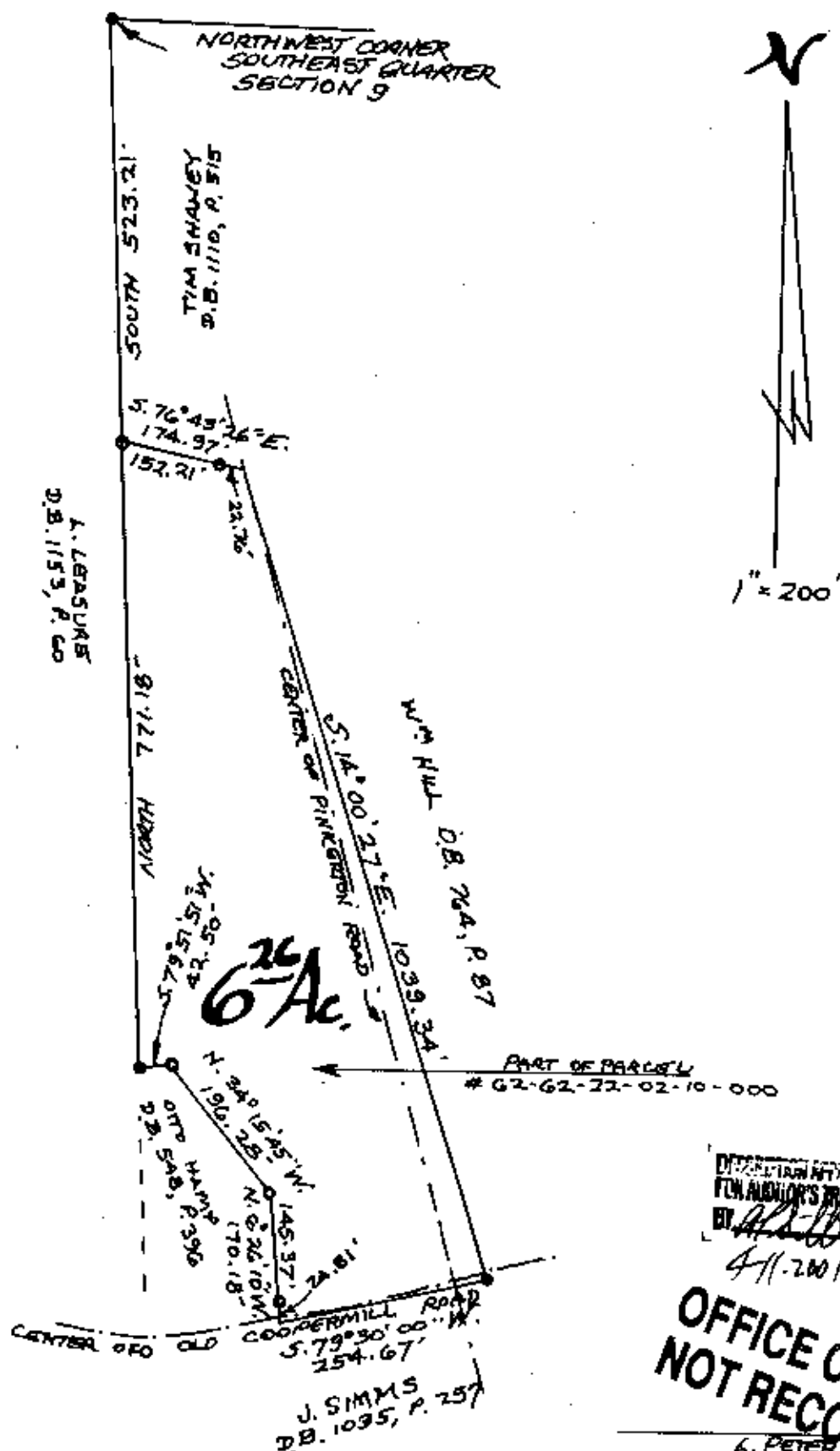
