- #1- THENCE South 87 degrees 27 minutes 39 seconds East 224.14 feet along the common line for said Northwest and Southwest Quarters to an iron pin (set), passing an iron pin (set) at 166.29 feet;
- #2- THENCE South 02 degrees 46 minutes 09 seconds West 474.96 feet into said Southwest Quarter and through said Leasure property to an iron pin (set);
- #3- THENCE South 17 degrees 22 minutes 17 seconds West 173.98 feet continuing through said Leasure property to an iron pin (set);
- #4- THENCE South 08 degrees 30 minutes 52 seconds East 317.80 feet continuing through said Leasure property to an unmarked point in the centerline of Old Coopermill Road, passing an iron pin (set) at 296.18 feet;

- #6- THENCE North 08 degrees 30 minutes 52 seconds West 400.30 feet leaving said road and along said Leasure and Parks properties to a metal reading under an 8 inch sassafras tree from which a bolt (found) for reference bears South 44 degrees 36 minutes 04 seconds West 0.60 feet, passing axles (found) at 25.92 feet and 218.22 feet;
- #7- THENCE North 87 degrees 04 minutes 00 seconds West 115.63 feet continuing along said properties to an iron pipe (found) on the common line for Sections 8 and 9 of said Township and Range;
- #8- THENCE North 02 degrees 46 minutes 09 seconds East 573.58 feet along said Section line to the place of beginning, passing a stone (found) at 530.02 feet and iron pipe (found) at 530.87 feet, containing 3.40 acres, of which 0.02 acres are within the right of way of Old Coopermill Road.
