

Commencing at the Northwest corner, of said Section #10, also being the Northeast corner of Section #9, of said Township and Range; thence (by deed) S 06 14 00 W 311.05 feet along the common line for Sections #9 & #10 to the center of County Road #34 (Ridge Road); thence N 86 45 30 E 98.78 feet along the center of said roed to an unmarked point; thence N 83 43 20 E 68.10 feet centinuing along said road to an unmarked point; thence N 78 42 30 E 59.93 feet continuing along said road to an unmarked point; thence N 78 42 30 E 59.05 feet continuing along said road to an unmarked point; thence N 72 47 20 E 59.05 feet continuing along said road to an unmarked point; thence N 67 11 00 E 111.53 feet continuing along said road to an unmarked point; thence N 60 28 30 E 54.06 feet continuing along said road to an unmarked point; thence N 55 58 30 E 42.45 feet continuing along said road to the Northeast corner of a 0.955 acre parcel owned by Jerry Tucker described in deed reference 1132, Page 989; thence S 11 00 10 W 239.53 feet along the common line for said 0.955 acre parcel end Maple property to en iron pin (set) at the place of beginning for the property herein intended to be described, passing an iron pipe (found capped 6553) at 36.16 feet;

- #1- thence S 84 55 50 E 456.48 feet through said Maple property to an unmarked corner within an existing pond, pessing an iron pin (set) at 321.52 feet;
- #2- thence S 01 28 50 W 75.00 feet continuing through said Maple property and within said pond to the unmarked Northeast corner of a 0.813 acre parcel owned by Jerry Tucker and recorded in deed reference Deed Book 1132, Page 989;
- #3- thence N 84 54 00 W 468.92 feet along a common line for said 0.813 acre parcel and the Maple property leaving said pond to an iron pipe (found capped 6553) at the common corner for said 0.813 acre parcel, said 0.965 acre parcel, said Maple property and a 4.01 acre parcel owned by Jerry Tucker recorded in deed reference Deed Book Volume 989, Page 187;
- #4- thence N 11 00 10 E 75.00 feet along the common line of said 0.955 acre parcel and Maple property to the place of beginning containing 0.79 acres.
