COMMENCING AT AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHWEST CORNER OF THE SAID NORTHWEST QUARTER;

THENCE WITH THE WEST LINE OF THE SAID NORTHWEST QUARTER, NORTH 00 DEGREES 27 MINUTES 43 SECONDS WEST 236.72 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE SOUTH AND EAST LINES OF A 0.905 MORE OR LESS ACRE TRACT, THE NEXT THREE COURSES AND DISTANCES:

- 1) **NORTH 42 DEGREES 36 MINUTES 07 SECONDS EAST 215.75 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);**
- 2) **WITH A CURVE TO THE LEFT HAVING A RADIUS OF 145.94 FEET (CHORD BEARING NORTH 23 DEGREES 07 MINUTES 17 SECONDS EAST 97.34 FEET) AN ARC DISTANCE OF 99.24 FEET TO A POINT;**
- 3) **NORTH 03 DEGREES 38 MINUTES 27 SECONDS EAST 46.01 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);**

THENCE WITH THE EAST LINE OF A 0.79 MORE OR LESS ACRE TRACT, NORTH 03 DEGREES 38 MINUTES 27 SECONDS EAST 128.99 FEET TO A POINT;

THENCE LEAVING THE SAID EAST LINE, SOUTH 86 DEGREES 21 MINUTES 33 SECONDS EAST 50.00 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE SOUTH 77 DEGREES 37 MINUTES 08 SECONDS EAST 326.27 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 65.00 FEET;

THENCE SOUTH 18 DEGREES 09 MINUTES 05 SECONDS EAST 239.79 FEET TO AN IRON PIN SET;

THENCE NORTH 73 DEGREES 03 MINUTES 52 SECONDS WEST 422.83 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 357.83 FEET;

THENCE NORTH 03 DEGREES 38 MINUTES 27 SECONDS EAST 175.00 FEET TO THE PLACE OF BEGINNING;

THENCE SOUTH 03 DEGREES 38 MINUTES 27 SECONDS WEST 175.00 FEET TO AN IRON PIN SET;

THENCE WITH CURVE TO THE RIGHT HAVING A RADIUS OF 337.29 FEET (CHORD BEARING SOUTH 21 DEGREES 03 MINUTES 38 SECONDS WEST 201.96 FEET) AN ARC DISTANCE OF 205.11 FEET TO AN IRON PIN SET;

THENCE CONTINUING WITH THE CURVE TO THE RIGHT HAVING A RADIUS OF 337.29 FEET (CHORD BEARING SOUTH 40 DEGREES 32 MINUTES 30 SECONDS WEST 24.26 FEET) AN ARC DISTANCE OF 24.26 FEET TO A POINT;

THENCE WITH A CURVE TO THE LEFT HAVING A RADIUS OF 212.97 FEET (CHORD BEARING SOUTH 22 DEGREES 54 MINUTES 47 SECONDS WEST 143.51 FEET) AN ARC DISTANCE OF 146.37 FEET TO A POINT;

THENCE SOUTH 03 DEGREES 13 MINUTES 27 SECONDS WEST 142.81 FEET TO A POINT ON THE SOUTH LINE OF THE ABOVE SAID NORTHWEST QUARTER;

THENCE WITH THE EAST LINE OF A TRACT CONVEYED TO STEVE TILLEY (DEED BOOK VOLUME 1143 PAGE 485), SOUTH 03 DEGREES 27 MINUTES 47 SECONDS WEST 258.44 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE WITH THE NORTH LINE OF A 0.053 ACRE PARCEL, SOUTH 43 DEGREES 23 MINUTES 13 SECONDS EAST 64.41 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);
