COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHWEST QUARTER OF SAID SECTION 10, THENCE, NORTH 85 DEGREES - 12 MINUTES - 28 SECONDS WEST, 1387.04 FEET TO A POINT; THENCE, NORTH 05 DEGREES - 15 MINUTES - 07 SECONDS EAST, 249.61 FEET TO A POINT; THENCE, NORTH 02 DEGREES - 12 MINUTES - 31 SECONDS EAST, 195.92 FEET TO A POINT; THENCE, NORTH 04 DEGREES - 37 MINUTES - 00 SECONDS WEST, 129.46 FEET TO A POINT; THENCE, NORTH 05 DEGREES - 35 MINUTES - 02 SECONDS WEST, 476.69 FEET TO A POINT IN COOPERMILL ROAD; THENCE, NORTH 33 DEGREES - 48 MINUTES - 41 SECONDS EAST, 16.83 FEET TO A POINT IN SAID ROAD; THENCE, SOUTH 86 DEGREES - 16 MINUTES - 04 SECONDS EAST, 497.86 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF THOSE LANDS RECORDED IN DEED VOLUME 721, PAGE 92; THENCE, NORTH 04 DEGREES - 33 MINUTES - 31 SECONDS EAST, 94.13 FEET TO AN IRON PIN SET, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED;

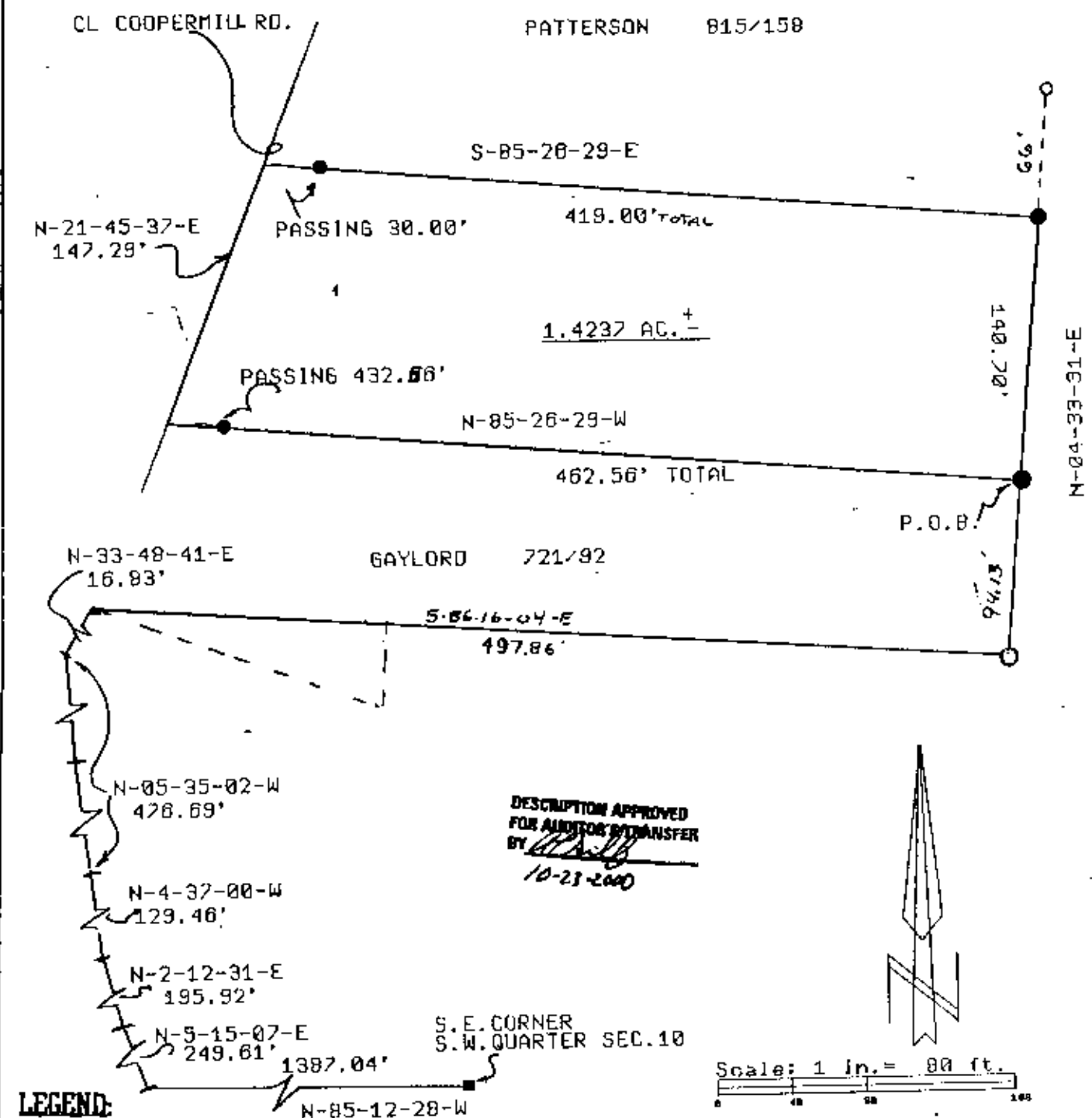
