

Re-Survey of Karen Anna Property on Owens Street

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and being part of the Northwest Quarter of Section 11, and being all of Lots 151, 153, 154, and part of Lot 152, of the Owen's Addition to Zanesville, Township 16, Range 14, Congress Lands East of the Scioto River, and being the same lands presently owned by Karen Anna, as per OR 1646-222, and being more particularly described as follows:

Beginning for reference and the principal place of beginning, at an iron pin set at the Northwest Corner of Lot 151, of the Owen's Addition to Zanesville, as per Plat Book 2, Page 112;

Thence along the south side of Owens Street, North 71 degrees 06 minutes 18 seconds East, 160.00 feet to an iron pin set on the northwest corner of lands presently owned by M. L. Lavender(OR 1907-690);

Thence along the west line of said Lavender lands and the west line of Lot 155, South 15 degrees 59 minutes 45 seconds East, 209.43 feet to an iron pin set on the centerline of vacated Bank Street as per Pl. Bk. 17, Pg 2, an the north line of lands presently owned by Clayfish LLC(OR 1128-142);

Thence along the north line of said Clayfish lands, and the centerline of said vacated street, South 71 degrees 32 minutes 37 seconds West 80.47 feet to an iron pin set on the southeast corner of Lot 152, and the southeast corner of lands believed to be owned by J. B. Owens;

Thence along the lines of said Owens lands the following three courses:

- 1.) Along the east line of Lot 152, North 15 degrees 51 minutes 34 seconds West, 68.84 feet to an iron pin set;
- 2.) Across Lot 152, South 71 degrees 07 minutes 05 seconds West, 40.17 feet to an iron pin set on the west line of Lot 152;
- 3.) Along the west line of Lot 152, South 15 degrees 47 minutes 23 seconds East, 66.82 feet to an iron pin set on the north right of way of Dearborn Street;

Thence along said right of way, North 65 degrees 55 minutes 45 seconds West, 52.03 to a point in a twin 24 inch diameter Oak tree, and the south east corner of lands presently owned by R. W. West(OR 1515-90), and being the southeast corner of Lot 150;

Thence along the east line of said West lands, and along the lot line, North 15 degrees 47 minutes 23 seconds West, 171.30 feet to the principal place of beginning, passing an iron pin set at 2.00 feet, containing 0.69 acres more or less.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars , 30 inches long, with plastic identification caps.

Bearings are based on the south line of the property as being South 71 degrees 32 minutes 37 seconds West, as per OR 1128-142.
