Situated in the State of Ohio, County of Muskingum, Township of Springfield, Township 16, Range 14, Section 11, bounded and described as follow:

Commencing at a stone in metal box with metal cap cover found at the Southeast Corner of the Southwest Quarter of Section 11; Thence on Section line North  $87^{\circ}05'02''$  West 581.20 feet to a stone found; Thence North  $12^{\circ}47'52''$  East 239.95 feet to a point; Thence North  $8^{\circ}02'26''$  East 208.70 feet to an iron pin the place of beginning; Thence North  $81^{\circ}57'34''$  West 252.23 feet to an iron pin set; Thence North  $8^{\circ}02'26''$  East 172.70 feet to a iron pin set; South  $81^{\circ}57'34''$  East 252.23 feet to an iron pin set; Thence along the West line of a 30.00 foot access right of way South  $8^{\circ}02'26''$  West 172.70 feet to the place of beginning containing 1.00 acres more or less:

Also the right of way for access to Potts Lane the center of which is described as follows:

Commencing at the Northeast Corner of above description; Thence South  $81^{\circ}57'34''$  East 15.00 feet to a point in the center of said right of way; Thence along the center the following 6 courses and distances: South  $8^{\circ}02'26''$  West 333.56 feet to a point, South  $73^{\circ}51'09''$  East 202.87 feet to a point, North  $69^{\circ}49'34''$  East 24.00 feet to a point, North  $56^{\circ}02'19''$  East 90.08 feet to a point, North  $50^{\circ}25'47''$  East 417.49 feet to a point and North  $59^{\circ}58'06''$  East 146.78 feet to Potts Lane:

Iron pins set are No. 5 reinf. bars 30 inches long with plastic ID caps.


