

DESCRIPTION OF SURVEY FOR KROUS RENTALS

JOB#1769-2

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Southeast Quarter, of Section 11, of Township 16, Range 14, of the Congress Lands East of the Scioto River, further being part of the Krous Rentals property recorded in Official Record Volume 2170, Page 734, of said county's deed records, further being part of Muskingum County Auditor's Parcel Number 62-31-03-21-000, and more particularly described as follows;

Commencing at an iron pin (found) at the common corner for Sections 11, 12, 13, & 14 of said Township and Range;

- TIE-1** THENCE North 86 degrees 27 minutes 45 seconds West 208.11 feet along the common line for said Sections 11 and 14 to an iron pin (found) at a common corner for the Jo Clyde Armstrong and Andrew Armstrong property recorded in Official Record Volume 2085, Page 18 and for the Vicki Lovingshimer property recorded in Official Record Volume 1717, Page 184;
- TIE-2** THENCE North 03 degrees 17 minutes 30 seconds East 410.30 feet into said Section 11 and along said Armstrong and Lovingshimer properties to an iron pin (found) at the Southeast corner of said Krous Rentals property;
- TIE-3** THENCE North 81 degrees 41 minutes 10 seconds West 482.90 feet along said Krous and Armstrong properties to an iron pipe (found);
- TIE-4** THENCE North 02 degrees 41 minutes 10 seconds East 782.55 feet continuing along said Krous and Armstrong properties to an iron pin (set) at the place of beginning for the property herein intended to be described;
- #1-** THENCE North 02 degrees 41 minutes 10 seconds East 200.00 feet continuing along said Krous and Armstrong properties also being on the East right of way of Woody Lane (Township Road #1646) to an iron pin (found) at the Southwest corner of a 10 foot wide parcel surveyed from the Krous Rentals property intended to be transferred to Lepetomane XXI, Inc. to date not transferred;
- #2-** THENCE South 86 degrees 11 minutes 20 seconds East 491.47 feet leaving Woody Lane and along the South line for said 10 foot wide parcel to an iron pin (found) within the right of way for Benjamin Avenue (Township Road #1119);
- #3-** THENCE South 03 degrees 17 minutes 30 seconds West 211.68 feet along the East line of said Krous property and within Benjamin Avenue to an iron pin (found) at the Southeast corner of the Larry Mumaw and Genevieww Mumaw property recorded in Deed Book Volume 567, Page 348;
- #4-** THENCE North 87 degrees 17 minutes 50 seconds West 349.18 feet leaving Benjamin Avenue and along said Krous and Mumaw properties to an iron pipe (found) passing an iron pipe (found) at 14.64 feet;
- #5-** THENCE North 78 degrees 41 minutes 45 seconds West 141.55 feet crossing said Krous property to the place of beginning, containing 2.40 acres of which 0.06 acres are within the right of ways for Woody Lane (Township Road #1646) and Benjamin Avenue (Township Road #1119).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

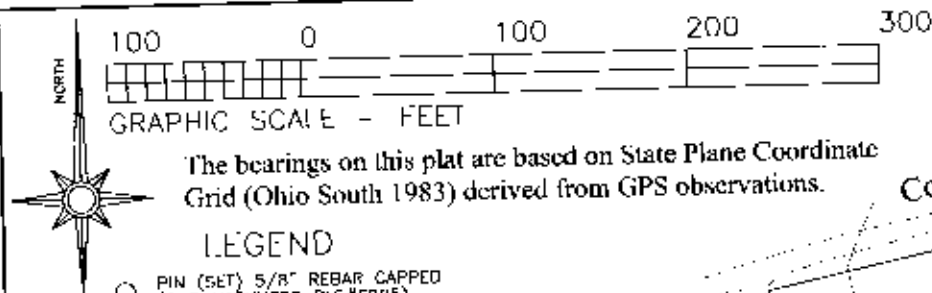
