

DESCRIPTION OF SURVEY FOR MARK STINE

JOB#780-1

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Southeast Quarter, of Section #11, Township #16, Range #14, of the Congress Lands East of the Scioto River, being that portion of the Howard & Karen Jenkins property described in deed reference Deed Book Volume 792, Page 266 of said county's deed records, known as Muskingum County Auditor's Parcel Number 62-31-03-59-000, lying South of Chaps Run and more particularly described as follows:

Commencing at the Southeast corner of Section #11, also being the Northeast corner of Section #14 of said Township and Range; thence (by deed) N 85 46 40 W 1458.57 feet along the common line for said Sections #11 and #14 to an axle (found) at the Southwest corner of Clyde Dutro property described in deed reference Deed Book Volume 528, Page 196, also being the place of beginning for the property herein intended to be described;

- #1- thence N 85 46 40 W 250.06 feet continuing along the common line for said Sections #11 & #14 to an iron pin (set) at the Southwest corner of said Jenkins property also being the Southeast corner of the J. Lowry property described in deed reference Deed Book Volume 1000, Page 20, from which an axle (found) on said common Section line, at the Northwest corner of Woodside Subdivision located in Section #14 and recorded in Plat Book 3, Page 24 bears for reference N 85 46 40 W 361.96 feet;
- #2- thence N 03 22 10 E 1385.26 feet along the West line of said Jenkins property to the center of Chaps Run, passing an iron pin (set) at 1357.05 feet, from said point in Chaps Run an iron pipe (found) at the Northwest corner of said Jenkins property bears for reference N 03 22 10 E 404.95 feet;
- #3- thence S 83 23 00 E 64.27 feet through said Jenkins property and along Chaps Run (downstream) to the common Southern corner for said Jenkins property and the B & D Braglin property described in deed reference Deed Book Volume 1128, Page 31, from which an iron pin (found) on the common line for said Jenkins and Braglin properties bears for reference N 03 29 00 E 30.00 feet;
- #4- thence S 82 45 30 E 47.41 feet continuing along Chaps Run and along a common line for said Jenkins and Braglin properties to the common Southern corner said Braglin property and the A & E Forker property described in deed reference Deed Book Volume 1002, Page 167, from which an iron pin (found) on the common line for said Braglin and Forker properties bears for reference N 03 29 00 E 30.00 feet;
- #5- thence S 78 35 50 E 46.82 feet continuing along Chaps Run and along a common line for said Jenkins and Forker properties to the common Southern corner said Forker property and the B Blanton property described in deed reference Deed Book Volume 1115, Page 491;
- #6- thence S 89 23 10 E 48.62 feet continuing along Chaps Run and along a common line for said Jenkins and Blanton properties to the common Southern corner said Blanton property and the C & M Bradshaw property described in deed reference Deed Book Volume 1052, Page 101;
- #7- thence S 85 50 40 E 47.06 feet continuing along Chaps Run and along a common line for said Jenkins and Bradshaw properties to the common corner for said Jenkins and Bradshaw properties and for the J Black property described in deed reference Deed Book Volume 756, Page 289, and for the Penny Powelson property described in deed reference Deed Book Volume 805, Page 40, from which an iron pipe (found) on the common line for said Bradshaw and Black properties bears for reference N 03 29 00 E 35.93 feet;
- #8- thence S 03 30 50 W 1377.29 feet along the East line of said Jenkins property and West lines of said Powelson and Dutro properties to the place of beginning, passing an iron pin (set) at 23.71 feet and passing an iron pin (found) at the common Western corner for said Powelson and Dutro properties at 243.13 feet, containing 7.97 acres.

The bearings within the description are based on the South line of Section #11 as described in deed reference Deed Book Volume 824, Page 317. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

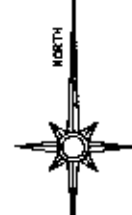

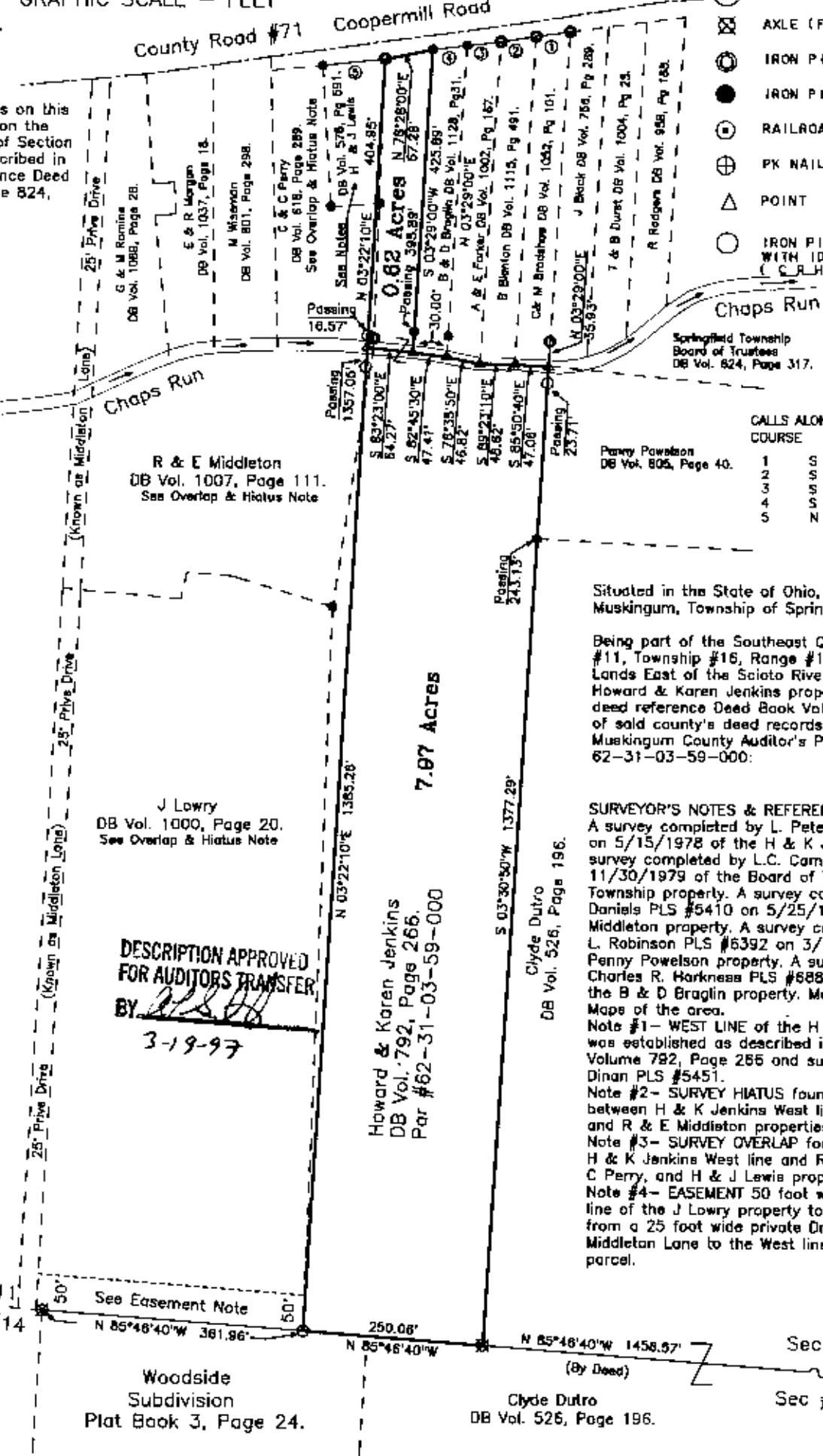
