

DESCRIPTION OF SURVEY FOR CHARLES & DELIE GILLESPIE

JOB#653-2

Situated in the State of Ohio, County of Muskingum, Township of Springfield:

Being part of the Southeast Quarter, of Section #18, Township #16, Range #14, of the Congress Lands East of the Scioto River, being part of the Charles & Delie Gillespie property as described in deed reference Deed Book Volume 902, Page 54 of said county's deed records, also being part of Muskingum County Auditor's Parcel Number 62-62-36-01-10-000, and more particularly described as follows;

Commencing at a stone (found) at the center of said Section #18; thence S 87 03 00 E 262.35 feet along the North line of said Southeast quarter of Section #18 to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- thence S 87 03 00 E 301.29 feet continuing along the North line of said Southeast Quarter to an iron pin (set) at the Northwest corner of a 3.00 acre parcel also surveyed from said Gillespie property, from which a stone (found) marked with an X at the common Southern corner of the West and East Half of the Northeast Quarter of said Section #18 also being the common corner for the Larry & Constance Tedrick property as described in deed reference Deed Book Volume 800, Page 140 and the Carl & Eva Creeks property as described in deed reference Deed Book Volume 429, Page 370, bears for reference S 87 03 00 E 793.25 feet;
- #2- thence S 02 57 00 W 293.14 feet along the West line of said 3.00 acre parcel to an iron pin (set);
- #3- thence N 85 32 10 W 301.39 feet through said Gillespie property to an iron pin (set);
- #4- thence N 02 57 00 E 285.18 feet continuing through said Gillespie property to the place of beginning, containing 2.00 acres.

ACCESS:

Access to the above described 2.00 acre parcel is to be by and through the described 3.00 acre parcel surveyed from the Gillespie property.

The bearings within the description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).

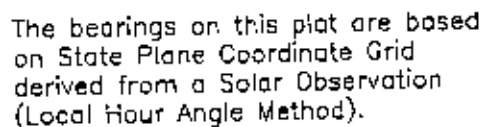

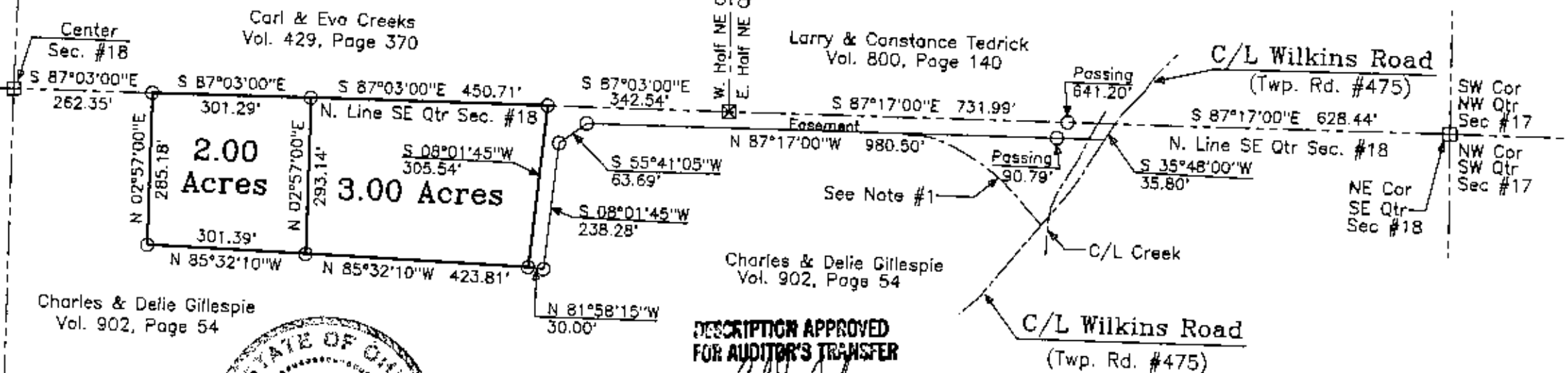

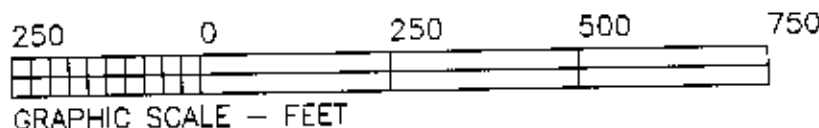
