**LEGAL DESCRIPTION FOR JERRY SODE**

Situated in the State of Ohio, County of Muskingum, Township of Springfield, and being part of the southeast quarter of Section 17, Township 16, Range 14, and being part of those lands intended to be described in Deed Volume 1516, page 609; being further bounded and described as follows:

Commencing at an iron pipe found at the northwest corner of the southeast quarter of said Section 17, thence, along the mid-section line, south 02 degrees - 55 minutes - 20 seconds west, 422.87 feet to an iron pin found; thence, south 87 degrees - 25 minutes - 50 seconds east, 655.22 feet to an iron pin found, and the *true point of beginning* for the parcel herein intended to be described;

Thence, north 03 degrees - 30 minutes - 10 seconds east, 200.00 feet to an iron pin set;

Thence, south 86 degrees - 29 minutes - 50 seconds east, 400.00 feet to an iron pin set;

Thence, south 03 degrees - 30 minutes - 10 seconds west, 200.00 feet to a railroad spike set;

Thence, north 86 degrees - 29 minutes - 50 seconds west, 400.00 feet to the *point of beginning*, and containing 1.837 acres more or less.

Also to be included herein is a *twenty (20) foot wide ingress/egress easement*, the centerline of which being further described as follows: commencing at the northeast corner of the herein described 1.837 acre parcel, thence, south 03 degrees - 30 minutes - 10 seconds west, 47.63 feet along the east line thereof to the true point of beginning for this easement; thence, north 28 degrees - 47 minutes - 25 seconds east, 25.64 feet to a point; thence, north 22 degrees - 58 minutes - 10 seconds east, 107.40 feet to a point; thence, north 09 degrees - 50 minutes - 47 seconds east, 17.07 feet to a point in the centerline of County Road 71, and the terminus of this easement.

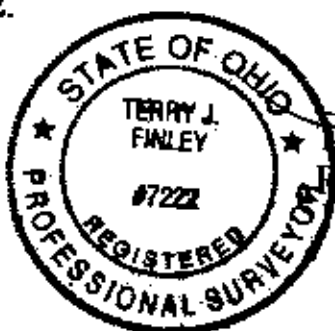
SUBJECT to all legal highways and easements of record, whether recorded or implied.

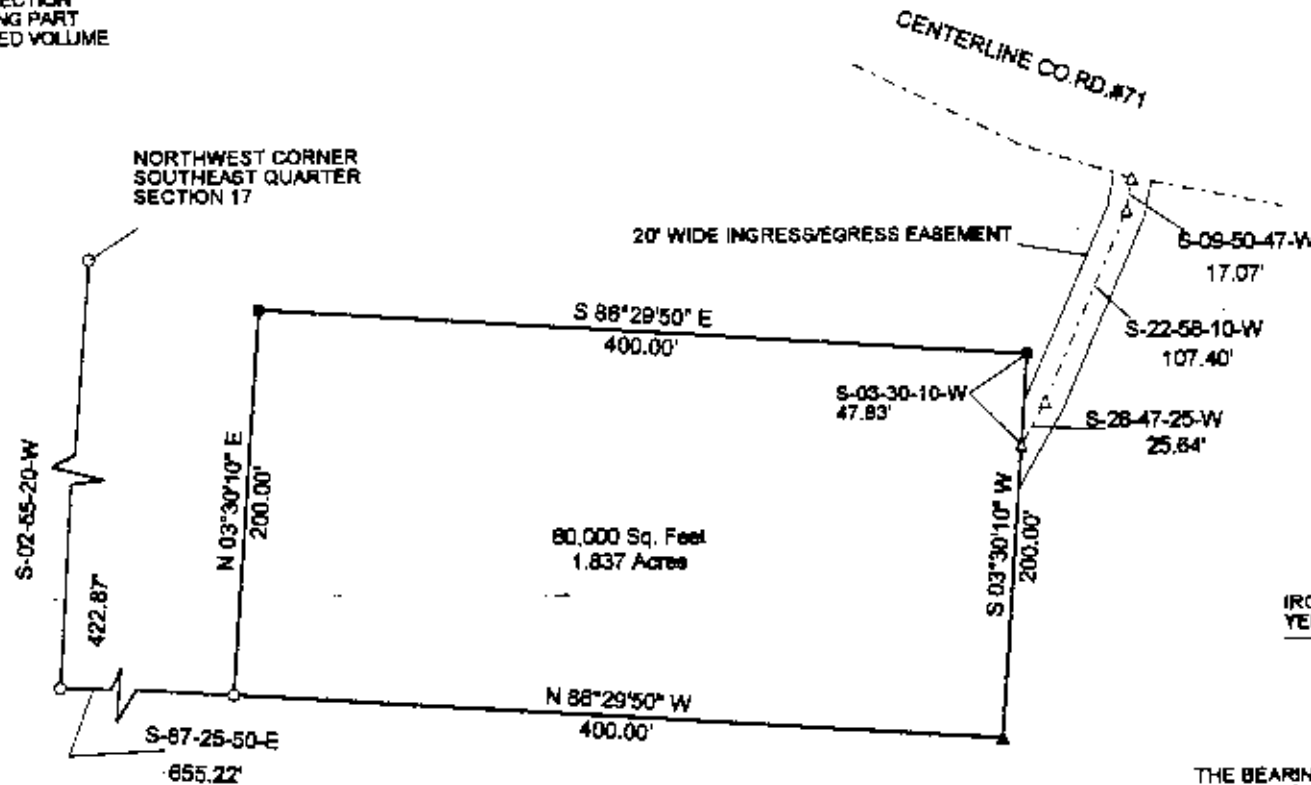
