E. & M. G. McHugh Volume 780, Page 212 of the Muskingum County Deed Records to a point; thence N 12°06'16" W, 456.47' to an iron pin (set); thence; N 35°42'46" E, 189.76' to an iron pin (set); thence, N 20°24'13" E, 170.80' to an iron pin (set); thence, N 18°13'27" W, 329.87' to an iron pin (set); thence, N 46°36'49" W, 211.17' to an iron pin (set); thence, N 58°10'27" W, 83.37' to an iron pin (found); thence, N 15°29'53" W, 43.92' to an iron pin (found); thence, N 38°54'07" W, 57.52' to an iron pin (found); thence, N 47°22'01" W, 28.54' to the centerline of New Coopermill Road; thence, along the centerline of New Coopermill Road the following six courses:

S 76°18'40" E, 165.74'
S 59°45'45" E, 147.00'
S 56°07'40" E, 142.16'
S 63°32'20" E, 42.17'

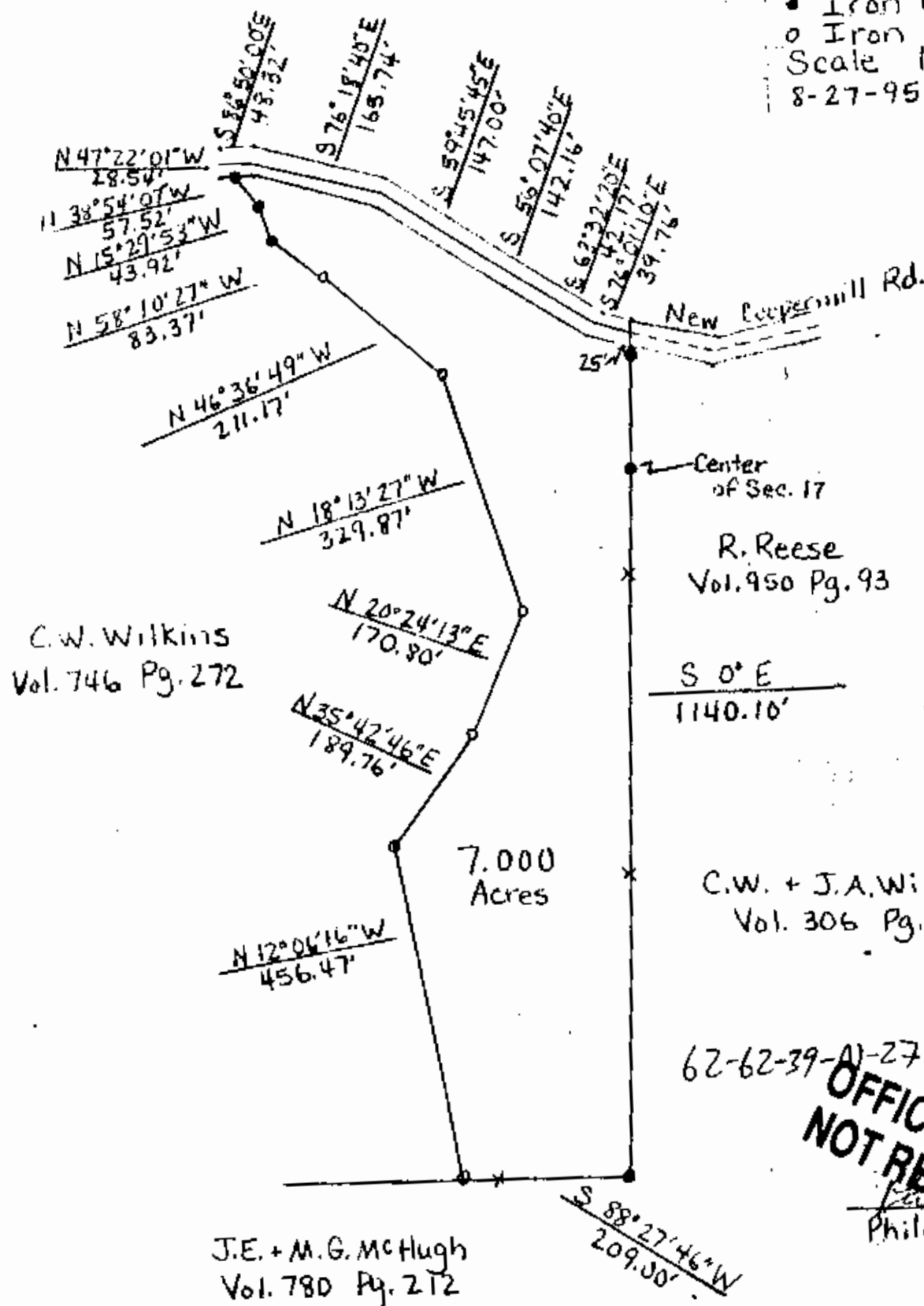
