

Being 4.000 acres located in the southwest quarter of Section 17, Township 16, Range 14, Springfield Township, Muskingum County, Ohio and being a part of the parcel recorded in Volume 746, Page 272 of the Muskingum County Deed Records described as follows:

Commencing at an iron pipe (found) at the center of aforementioned Section 17, thence S 0° E, 971.18' along the center of section line to an iron pin (found) at the southeast corner of the parcel described in the aforementioned Vol. 746, Pg. 272; thence, S 88°27'46" W, 555.28' to the center of a small stream and along the north line of a parcel owned by J. & M. McHugh as recorded in Vol. 780, Pg. 212 of the Muskingum County Deed Records; thence, S 86°37'15" W, 496.79' along the north line of the aforementioned J. & M. McHugh property to an iron pin (set) at the southeast corner of the property intended to be described and having passed through an iron pin (found) at 13.77'; thence, continuing along the same line S 86°37'15" W, 169.54' to an iron pin (found) at the southwest corner of the parcel described in Vol. 746, Pg. 272 of the Muskingum County Deed Records; thence N 0°23'13" E, 1033.96' along the east line of the J. & M. McHugh parcel described in Vol. 780, Pg. 212 to an iron pin (found); thence, S 89°57'15" E, 169.54' to an iron pin (set) and along the south line of Meadow Farm Acres as recorded in Plat Book 14, Pages 17 and 18; thence, S 0°24'24" W, 1023.83' to the point of beginning.
