Being a part of the south east quarter of section 17, township 16, range 14, bounded and described as follows:

Commencing at the northwest corner of said southeast quarter of section 17; thence south 55 degrees 46 minutes 26 seconds east along the half section line a distance of 1325.00 feet to a point; thence south 04 degrees 13 minutes 34 seconds west a distance of 381.50 feet to a point in the centerline of Coopermill Road at the true place of beginning for the parcel herein intended to be described; thence south 74 degrees 47 minutes 01 seconds along said centerline a distance of 186.43 feet to a point; thence south 83 degrees 03 minutes 35 seconds east along said centerline a distance of 99.87 feet to a point; thence south 03 degrees 11 minutes 00 seconds west along the westerly line of lands now or formerly owned by D. Harding and recorded in deed book 130, page 207 of the deed records of said county a distance of 176.39 feet to an existing iron pin and passing through an iron pin at 25.00 feet; thence south 59 degrees 16 minutes 15 seconds west along the northerly line of lands now or formerly owned by H. Greiner and recorded in deed book 340, page 702 of the deed records of said county a distance of 192.75 feet to an existing iron pin; thence north 04 degrees 13 minutes 34 seconds east along the easterly line of lands now or formerly owned by W. Wilkins and recorded in deed book 306, page 453 of the deed records of said county a distance of 210.12 feet to the true place of beginning and passing through an iron pin at 195.12 feet, containing Eighty Eight (0.88) hundredths acres more or less.

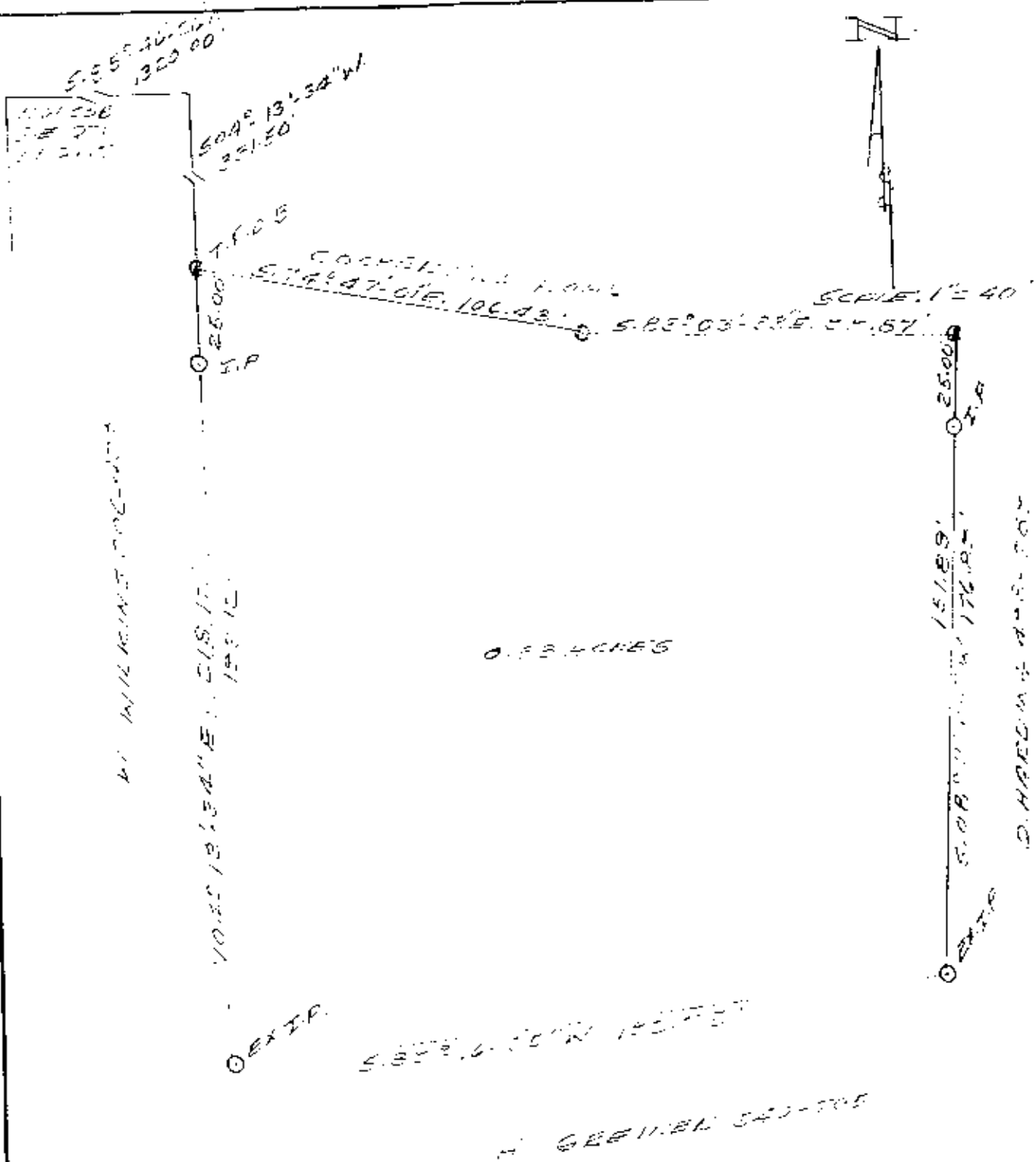
