Situated in the State of Ohio, County of Muskingum, Township of Springfield, Southwest Quarter, of Section #15, of Township #16, Range #14, of the Congress Lands East of the Scioto River:

Being part of the prior deed reference Volume 1002, Page 139 of said county's deed records, also being part of Muskingum County Auditor's Parcel Numbers 52-62-47-01-11-000, and more particularly described as follows:

Commencing at an axle (found) at the Southwest corner of said Section #15; thence along the West line of said Section #15 N 03 05 35 E 1,814.41 feet to a stone (found) at the Northwest corner of the prior deed reference Volume 1002, Page 139; thence along a North line of said prior deed reference S 68 38 48 E 755.70 feet to an iron pin (found); thence continuing along a North line of said prior deed reference S 86 38 25 E 421.51 feet to a stone (found) by a previous survey of the prior deed reference, also being the place of beginning for the property herein intended to be described;

- #1- thence along a North line of said prior deed reference S 86 38 25 E 557.70 feet to an iron pin (found) from a previous survey of the prior deed reference;
- #2- thence through said prior deed reference S 49 07 49 W 993.57 feet to the center of County Road #125 (Pinkerton Road), passing an iron pin (set) at 968.57 feet;
- #3- thence along the center of said road N 45 27 56 W 105.71 feet to a point, from which an iron pin (set) for reference bears N 38 13 45 E 25.00 feet;
- #4- thence continuing along the center line of said road N 56 59 36 W 97.67 feet;
- #5- thence N 32 21 05 E 657.54 feet to the place of beginning, passing an iron pin (set) at 25.00 feet containing 5.930 acres.

The bearings within this description are based on iron pins (found), from a previous survey completed by Charles R. Harkness RS #6885, January 22, 1986, on the property described in deed book Volume 1002, Page 139. Iron pins (set) are 5/8" rebar with aluminum identification caps (C.R.Harkness R.S.6885).

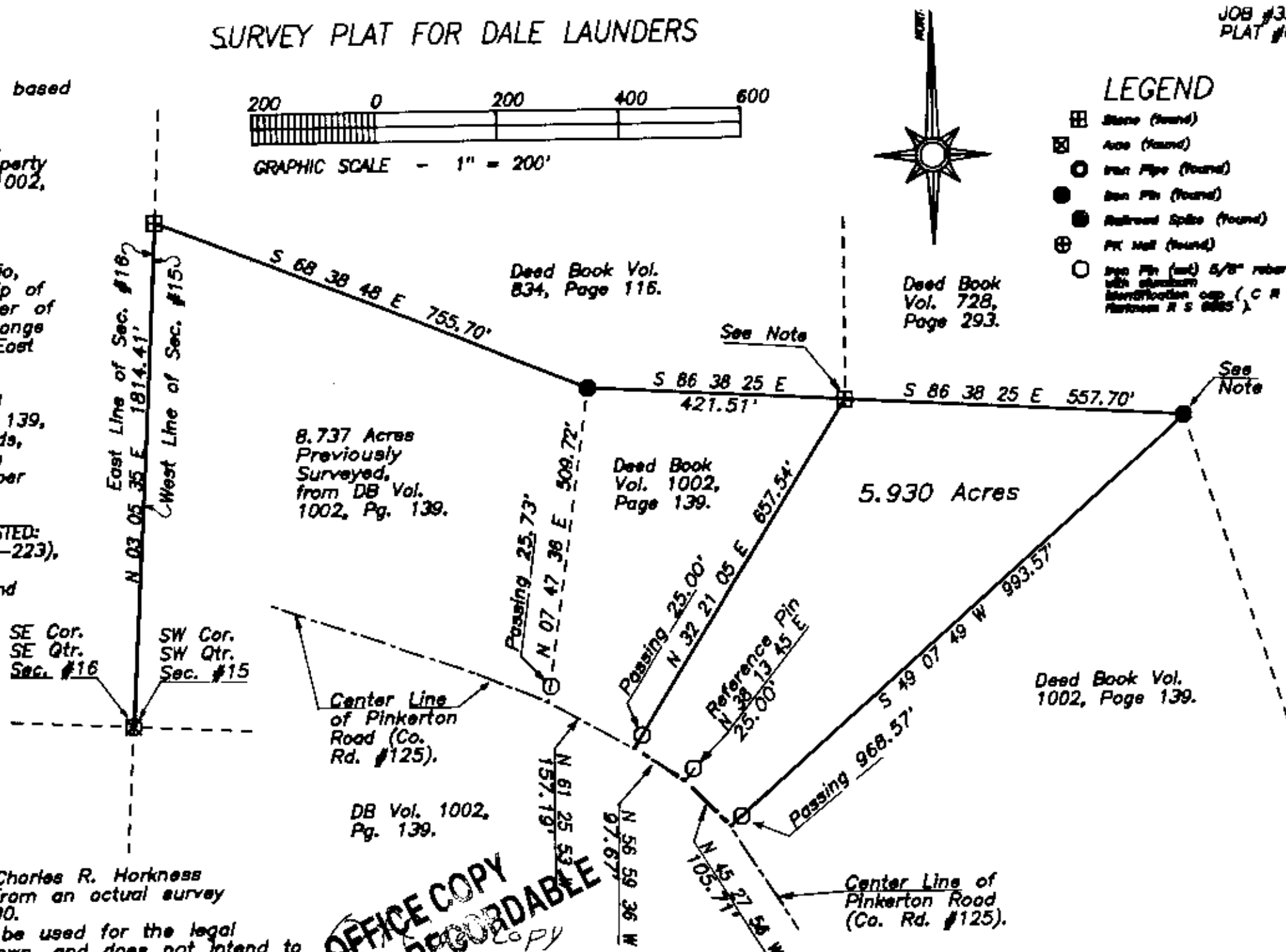
